

Barren County Fiscal Court met in regular session on May 6. All magistrates were present except Tim Durham and County Attorney Mike Richardson.

The anticipated second reading of a solar farm ordinance was not addressed and Judge/Executive Jamie Byrd cited the reason being the absences of Durham and Richardson. Byrd also said magistrates should

provide clarification to the county attorney for language amendments for the ordinance. It is expected to be held at the next meeting, May 20. Byrd encouraged constituents to reach out to their magistrates with concerns before the meeting. Contact 270-651-3338 if you need to reach your magistrate.

Other items approved by the court include:

- \$11,250 to the Barren River Area Development District for their technical assistance and administrative services:

- \$14,696 to Team First Services for a final payment for baseball and softball uniforms;

- Amanda Proffit appointment as Voluneer Deputy Director of the local emergency manage-

ment.
