New Animal Ordinance

Glasgow City Council met in a special-called meeting on May 27. The meeting was considered special-called due to its regular meeting date falling on Memorial Day holiday, the evening

In new business, the council approved the first reading of an ordinance relating to animals in the city.

While most of the original ordinance includes animal regulations for animals, including dogs, cats, fowl, and livestock, the ordinance establishes a more concrete penalty section for specific violations and removes language that required cats to be leashed. Dogs must still remain leashed

at all times.

Nuisance hours are set between the hours of 9 p.m. and 8 a.m. inside the city limits. Some of those nuisances include continuous barking, yelping, etc., without obvious cause, pets trespassing upon other properties, damaging or disturbing items, defecating or urinating on properties not owned by the animal owner, and chasing of any vehicle. A penalty section is also established if a female dog is not confined while in heat.

The largest addition to the animal-related city ordinance pertains to the seizure of an animal without a warrant.

"If an Animal Control Officer (ACO) or peace officer witnesses a situation in which the ACO or peace officer determines that the health or life of an animal is in jeopardy and immediate action is required to protect the health [or] safety of the animal, the ACO or peace officer may seize the animal without a warrant; and the animal shall be immediately transported to BRAWA, where the health of the animal shall be assessed, and if necessary medical treatment rendered," the ordinance reads.

It also provides language that removes any liability of an ACO or officer if they have acted reasonable within the course and scope of their duties, and written notice of an impoundment must be given to the seized animal owner within three days; however, such a notice could be a posting at the place of impoundment rather than a delivery to the owner, which is also an option.

Section C of Article V also provides that a lien can be placed on an animal's property for the

expenses incurred for providing care for an impounded animal. An impounded animal cannot be released to its owner following a conviction for a violation until the lien has been satisfied, and if such expenses have not been paid within 15 days, ownership of the animal transfers to BRAWA, the local animal shelter.

ACO Shelly Furlong was present at the meeting to discuss the ordinance. She said the ordinance has not been updated since 1980.

Old business items approved included the second reading of an ordinance relating to ethical conduct code for city officials, employees, and its agencies, and a second reading of an ordinance amending the current fiscal year budget to account for \$98,400 for an interest payment on bond proceed funds.

A resolution was also approved declaring three out-of-service vehicles as surplus for the Glasgow Police Department: 2008 GMC Envoy (130,000 miles), 2006 GMC Canyon (120,000 miles), and 2013 Ford Fusion (129,000 miles).

A municipal order for the appointment of Aaron Woosley to the Board of Adjustments to fulfill the unexpired term of Jonathan Belcher, whose three-year term expires June 30, 2026, was also approved.

Nick Houchens with the Glasgow Police Department was promoted and took his oath of office as Lieutenant. Two new firefighters, Benton Estes and Luke Penrose, were also sworn in for the Glasgow Fire Department.

Near the meeting's conclusion, Glasgow Mayor Henry Royse announced an update on the Cleveland Avenue property, also known as the Johnson property. More details are provided in a related story this week on the planned sports complex.

In the city council meeting, however, Councilman Randy Wilkinson sought clarification on the sports complex and the presence of architect Rob Campbell with QK4 in the meeting. Royse said Campbell was present for questions as he has been

"We're not involved in building it," Royse said. "We're involved in providing a place for it to be." Royse said QK4's involvement with the Cleveland Avenue property is for developing the property.

Wilkinson asked what part of the 161-acre property would the 15 acres be located.

"The 15 acres specifically exactly where it fits on the property has not been finally determined yet," Campbell said. "They've only given us the amount of area they have to have and we're talking through the best positioning of that. That's something that

will be a group effort."

Councilman Freddie Norris asked, "So, the 15 acres, we don't actually give them the 15 acres, how do you state that?"

"It's our contribution to the project," Royse said. "But, we'll do that in the form of an official ordinance transaction that comes to the council when we have enough information from the architect and all that to put it into, for [City Attorney] Rich [Alexander] to write it in legal language."
