

REGIONAL - Kentucky health officials announced the first pediatric influenza death of the 2024-2025 respiratory virus season. Influenza (flu) is on the rise, and there have been widespread reports of flu and respiratory virus outbreaks across the Commonwealth.

Vaccination is the best way to prevent severe illness and death from the flu and COVID-19. It is important for people who have not been vaccinated this season to get their updated vaccinations. To find vaccines near you visit Vaccines.gov.

To prevent the spread of illness, Kentucky Department for Public Health also recommends to stay home if you are sick, wash hands often, cover coughs and sneezes and to consider wearing a mask if you are high-risk for serious illness. Donors who show love for Kentuckians will receive a \$15 Texas Roadhouse gift card as well as a coupon for a free appetizer. The promotion is only at KBC's donor centers.

KBC continues to dig out of major winter-weather disruptions from January and remains in urgent need of blood. Currently, KBC is in critical need of O- blood - meaning there is less than a day's supply of the type to provide more than 70 hospitals in Kentucky - and in low supply of A-. KBC lost an estimated 1,000-plus units of blood during a three-week period in January due to winter-weather cancellations. Transfusions have also been on the rise in 2025.

Donors can schedule an appointment at the links below, at kybloodcenter.org or call 800.775.2522. Appointments are encouraged. Walk-ins are welcomed.

KBC is the exclusive blood provider for UK HealthCare, Baptist Health, CHI Saint Joseph, Appalachian Regional Healthcare and more.

Blood donors must be at least 17 years old (16 with parental consent), weigh at least 110 pounds, be in general good health, show a photo I.D. and meet additional requirements.

# **ANOTHER ROUND OF INDICTMENTS** HANDED DOWN IN MARTIN COUNTY

The Martin County Grand Jury handed down six additional true bills when they met in regular session for Febru-

Among those indicted were Joe Allen Evans, 51, of Inez.

Evans was charged with assault in the second degree (domestic violence) when on Nov. 25, 2024, he unlawfully committed the offense of causing physical injury to Vicky Venturino by means of a deadly weapon or dangerous instrument.

Evans was also charged with persistent felony offender.

Ernest Jarvis, 51, of Inez, was charged with burglary in the second degree, criminal mischief in the second degree, resisting arrest and menacing. The indictment states that on Dec. 26, 2024, he unlawfully committed the offense of entering the dwelling of Rachale Fletcher with the intent to commit the crime of theft. He also committed the offense of damaging, destroying or defacing property owned by Fletcher with damages not exceeding \$500.

Jarvis also attempted to prevent Martin County Deputy Chris Kidd from effecting an arrest and also committed the offense of placing others in reasonable apprehension of imminent physical injury.

Brian D. Lowe, 55, of Pilgrim, was charged with fleeing/evading police second degree, wanton endangerment first degree (police officer), disregarding stop sign, careless driving and failure to own /maintain required insurance.

The indictment states that on Dec. 12, 2024, Lowe committed the offense of unlawfully disregarding Constable Brad Preece's signs and signals to stop. Preece also engaged in conduct which created substantial danger or death to another person namely Brad Preece. He committed the violation of disregarding a stop sign while also operating a motor vehicle in a careless manner with no regard for the safety of others

and failed to have insurance on the vehicle he was operating.

Brittany Gilmore, 35, of Inez, was charged with first degree bail jumping when on Dec. 5, 2024, she unlawfully committed the offense of failing to appear at the specified time and place as ordered by the court for her change of plea hearing.

Harlan Jude, 53, of Pilgrim, was charged with bail jumping first degree when on Dec. 5, 2024, he unlawfully committed the offense of failing to appear at the specified time and place as ordered by the court for his change of plea hearing.

Timothy Stacy, 53, of Kermit, was charged with bail jumping first degree when on Jan. 16. he unlawfully committed the offense of failing to appear at the specified time and place as ordered by the court for an arraignment hearing.


