Spring's a-comin', and y'all know what that means: mowers roaring at first light, fertilizer in every pickup, edges cut knifesharp. Here in Appalachia, ensuring our lawns look nice, is a tradition. Folks diligent invest concern, care, time, energy, sweat, and money to keep those lawns looking pristine. Nothing wrong with that, either. However, do we invest similarly on something far more important: our own hearts? Do we watch our own hearts like we watch our laws? That is—do we water our hearts with the Word; do we quickly pull-out any weeds that start to sprout; and do we examine our own hearts daily to make sure our hearts look pleasing to the Lord?

God's Word directs we "keep our hearts with all diligence, for out of it are the issues of

Life," (Proverbs 4:23), and "as a man thinketh in his heart, so is he." (Proverbs 23:7). Jesus said, "Blessed are the pure in heart, for they shall see God." (Matthew 5:8). Clearly, the importance of our heart's condition cannot be overstated. In the Parable of the Sower, Jesus explained that, in an unkept heart, the Word gets choked-off and produces nothing; "and some fell among thorns; and the thorns sprung up, and choked [the Word.]" (Matthew 13:7). Jesus elaborated, saying: "the cares of this world, and the deceitfulness of riches, and the lusts of other things entering in, chokes the Word, and it becomes unfruitful." (Mark 4:19). Note, Jesus spec-

ified that things "enter in." How does this happen?

This happens when we don't diligently keep our hearts; when we set our affections on earthly things—and not heavenly things. (Colossians 3:2). Remember, Jesus taught: "Where your treasure is, there will be your heart also." (Matthew 6:21). All this takes us back to our opening discussion about the near-religious devotion we in Appalachia give our lawns. Shouldn't we devote far more concern, focus, and energies toward keeping our hearts free from thorns' springing-up—thorns like cares of this world; riches' deceitfulness; and lusts for other things? Things like the lust of the flesh and the eyes, and the pride of life (I John 2:16). But how do we so keep, or attend to, our own hearts?


We "receive with meekness the engrafted Word, which is able to save our souls." (James 1:21). To "engraft" something, we must first cut-off something. If we will abide in Christ, the Father, will do the cutting-off, the pruning. (John 15:1-2). To abide in Christ requires diligent effort at hiding His Word in our hearts (Psalms 119:11); and not just being Bible-readers, but Bible-doers. (James 1:22). Peter wrote that "in obeying the truth," we "purify our souls." (I Peter 1:22). That's how it's done. We must all decide daily what we value most: our lawns, which soon wither, or our hearts before Him, which He will judge. (Revelation 2:23).
