# NEW THREAT LEADS TO A NEW CHARGE FOR LOUISA MAN


A Louisa man was arrested with an added charge after threatening his uncle in front of police.

According to a report by the Lawrence County Sheriff's Office, Deputy Tyler Laney was serving a warrant for Gary Asher 39, third-degree terroristic threatening and second-degree disorderly conduct stemming from an incident that occurred on Aug. 20, when he was in a disagreement with a family member that lived next door to him and they share a water supply. Asher pays the water bill that runs the pump to get water to both homes so because he was in the disagreement with the other family member Asher turned off the water to the family member's home knowing they would come to his home to try and get it back on after they were told they were not allowed to be on Asher's property, according to the police report.

At that time the uncle Lavern Brandt did tell police he did not go on Asher's property but did intend to sneak over there and turn the water back on but was caught by Asher.

Both Asher and Brandt stated that Brandt picked up a wagon wheel as if he were going to hit Asher with it and photos did show Brandt entered Asher's property and at that time Brandt was charged with third-degree criminal trespassing.

When Deputy Laney attempted to serve the war-



rant last Thursday, Asher became angry and told the deputy that he hated his uncle so badly that when he got out of jail he planned to get "juiced up and severely hurt him."

He was then given another charge of third degree terroristic threatening and lodged in the Big Sandy Regional Detention Center.

## KENTUCKY POWER ADDS NEW SURCHARGE TO MONTHLY BILLS

FRANKFORT — A new surcharge will appear on Kentucky Power customers' monthly bills. The surcharge will appear as the "Securitized Surcharge."

Kentucky Power received approval from the Kentucky Public Service Commission (PSC), in Case number 2023-00159, to utilize the securitization process to finance certain costs, which the PSC estimates is projected to save customers an estimated \$90 million over 20 years.

This approval allows Kentucky Power to issue bonds to recover previously incurred costs, such as the Big Sandy plant retirement costs, deferred major storm costs, and under-recovered purchased power rider costs secured by a non-bypassable charge on customer bills, according to the PSC.

Senate Bill 192, passed in 2023, enabled the PSC to approve qualifying utilities, such as Kentucky Power, to use securitization.

The PSC said Kentucky Power customers will see a 6.37% increase on their utility bills.

A spokesperson for Kentucky Power said in

a statement, "The cost savings provided by securitization means the rate impact is approximately \$14 for residential customers using 1300 kWh."

Without securitization, the PSC said that the increase would jump to 13.13%.

"Customers would have seen a substantially higher charge for these expenses - and would have already been paying it for the past year or more - if not for the securitization process," said PSC Chair Angie Hatton. "While seeing a new charge on a utility bill is never something customers want, this process has resulted in both an overall reduced monthly amount for individual customers and approximately \$90 million in total customer savings."

The surcharge will remain on customers' bills for the next 20 years, according to Kentucky

Around 162,000 customers in 20 eastern Kentucky counties will be affected. Records regarding this case are available on the PSC website, psc.ky.gov. The Case No. is 2023-000159.


