

AN ORDINANCE AMENDING THE NUISANCE ORDINANCE OF THE CITY OF BROOKSVILLE, KENTUCKY

WHEREAS, the city council has determined that certain provision of the current Nuisance Ordinance are outdated or not consistent with the processes in place with the City of Brooksville personnel; and

BE IT ORDAINED BY THE CITY OF BROOKSVILLE, KENTUCKY as follows:

1. The Nuisance Ordinance shall be updated, as attached and incorporated herein by reference, to remove Sections 92.06 Hearing Board and 92.07 Appeals, thereby streamlining the appeals process, and amending Section 92.99 Penalties to include prosecution in Bracken District Court.
