swimmers in each event as well as the top eight teams in team events move to Saturday's finals. The next eight individuals and teams swim in consolation rounds on Saturday to earn final placement in the regional competition.

The top two swimmers and teams in each event earn automatic qualifications for the first round of the KHSAA state championships. The next 10 top times from swim regions one, two, and three also qualify for state competition. While places first and second are determined the day of the meet, the remaining swimmers have to wait until all results are in to determine state placements.

Results from Saturday's final round for AC-S were good overall. Heading the list of achievements included a pair of results that will go down in the AC-S swim record book. In the boys 200-yard freestyle relay, the team of Kash Taylor, Ryan Wolfe, Alex Stamps, and Houston Porter posted a time of 1:36.92. While the time earned the squad a fourth place finish in the meet, it also was a school record—eclipsing the previous record of 1:37.80.

Results were similar in the 400y free. The same group of swimmers was third in the longer event with a time of 3:34.25. Again, the squad's time established a school record, besting the previous mark of 3:35.25.

Additional individual results from the final round included a fourth place finish by Porter in the 200y freestyle (1:52.06) and a fourth in the 100y free (51.07). Taylor earned a seventh place regional finish in the 50y free with a time of 23.64. In the 100y free, Taylor was sixth (51.89).



Wolfe swam in Saturday's consolation round in the 200y free and finished 12th overall (2:06.21). Wolfe was also ninth in the 100y back with a time of 1:03.53. Stamps placed 12th in the 50y free in the time of 25.17 and was ninth in the 100y free (54.60). Owen Powell notched a 14th place in the 500y free with a time of 5:47.61 and placed 10th in the 100y backstroke.

Lady Patriot swimmers also enjoyed a solid day in the water in the finals. The 200y medley relay team of Emma Brown (backstroke), Sarah Shain (breaststroke), Jayden Harmon (butterfly), and Anne Powell (freestyle) finished seventh in the time of 2:12.97. Brown, Lily Bullington, Shain and Harmon were sixth in the 400y free relay.

Harmon brought home a fifth place regional finish in the 50y free (27.61). Brown was sixth in the 100y fly (1:15.15) with Bullington 14th in the same event (1:35.61). In the 100y free, Harmon posted a time of 1:00.63 to place seventh with Shain having a time of 1:08.29 to place 16th.

Brown was fifth overall in the 100y backstroke with a time of 1:09.37. Powell placed 14th in the event in the time of 1:19.53. Shain was seventh in the 100-breast with the time of 1:22.98.

insurance.

A traffic stop was conducted on West Main Street.

Upon making contact with the operator, identified as James Duke Hicks, 28, of Scottsville, he couldn't provide registration to the vehicle. He stated he bought the vehicle in July of 2024 and didn't have the money to transfer the vehicle at this time.

Hicks was cited for failure to register transfer of a motor vehicle and a court date was issued. There were no incidents.

•On Saturday, Jan. 25 at 6:29 p.m., deputies observed a blue 2003 Dodge Ram truck make a right turn onto East Main Street without using a turn signal. A traffic stop was conducted on North Ninth Street.

Deputies made contact with the driver, identified as Donald Wade Harrison, 45, of Scottsville. They immediately detected a strong odor of marijuana coming from inside the vehicle. When questioned about the smell, Harrison claimed there was no marijuana in his vehicle.

Deputies conducted a probable cause search, during which marijuana was found in a clear plastic bag inside a storage compartment in the dashboard. Additionally, another clear bag containing suspected marijuana was discovered behind the driver's seat in a tool bag and two

rolled marijuana joints were located on the floorboard of the vehicle.

Harrison stated that he didn't know the marijuana was in his vehicle and said he "must have got high and forgot." He also informed the deputies on the scene that he had been stopped a couple weeks prior, during which deputies had seized a couple ounces of marijuana from him. Harrison expressed concern about potentially violating his probation due to this incident.

Citations for possession of marijuana and failure to signal were issued along with a court date. The marijuana was seized and logged into evidence at the Allen County Sheriffs Department.
