The 200y freestyle relay squad featuring seniors Kash Taylor, Ryan Wolfe, Alex Stamps, Houston Porter and alternate seventh-grader Owen Powell is seeded seventh with the time of 1:36.92. The same group is also seeded seventh in the 400y freestyle in the time of 3:34.25).

Individually, Houston Porter is seeded sixth in the 200y free (1:52.06) and ninth in the 100y free (51.07). Kash Taylor has qualified in the 100y free with a time

of 51.89, thus earning a 12th seed. Taylor is also in the 50y free with a 13th seed (23.64). Ryan Wolfe qualified for the first round in the 100y backstroke (1:03.53).

According to the KHSAA, 10:30 a.m. will be the start time for the girls. The boys session starts at 4 p.m. on Saturday, Feb. 8. The top three swimmers in each event are automatic qualifiers for the state championship round. The next best 15 times statewide per event will be

at-large qualifiers.

opportunity to be seen

and heard which leads to the chance to earn music opportunities at the collegiate level.

"There will be people from colleges at the concert," Eaton pointed out. "We had to sign a waiver saying it was okay if colleges reached out to us."

For Eaton, a second high honor has come his way. Eaton has been selected for an opportunity to perform with Music City Drum Corps—a marching band that includes brass instruments, color guard and a drum line. This Drum Corps is highly professional and considered 'the NBA' of marching bands."

Eaton earned the opportunity by his performance and presentation at an audition camp in December-a camp that showcases the talents of musicians from across America and even beyond its borders.

"I attended a camp in Franklin, Tenn.," Eaton elaborated. "Over the weekend we learned some show music. We worked on the fundamentals of marching. Throughout the three days, I was there, the camp staff watched how each person does. They decide whether or not you are offered a contract to march with them, if you are offered a call back to try again, or if you are not invited back."

Eaton was offered a contract, which means a spot to march with Music City this summer. The high honor carries with it a wide range of emotions.

"I'm excited and nervous," Eaton said. "It's going to be a lot."

Eaton graduates in May and will spend his summer marching. The experience will help the young man as he goes to college to prepare for a music education career.

"With drum corps on my résumé, I can pretty much get a job anywhere as a tech," Eaton pointed out. "The employers see your résumé and says, okay, this guy marched drum corps. He can show our kids what's up. I get to teach pretty much anyone I want. Drum Corps is also an opportunity to meet many people and make connections all across the US. There were people from all-over at the camp I attended. There were even two people from Puerto Rico.

Eaton will attempt camps each month until May at which time he packs his suitcase and starts a summer of practices and performances.

"We will be moving around and sleeping on gym floors," Eaton said. "It will be marching band rehearsals for 16 hours a day. If you have seen what we do here, it's 10-times more."

The opportunity is not without a price. Participants must cover expenses out of pocketexpenses that can cost in the thousands of dollars. Eaton adds that he is "fundraising" to help cover his expenses. Yet, Eaton realizes, it is a small price to pay to pursue his musical dreams.
