## **Boys Volleyball Is Newest Sport At Allen County-Scottsville**

Plans are underway to field the first Patriot volleyball team this spring at Allen County-Scottsville High School. The creation of a boys volleyball team has received approval from the Allen County Board of Education and applications are being accepted for a head coach and an assistant.

Growing interest in mens volleyball at the collegiate level across the Commonwealth led to the Kentucky High School Athletic Association (KHSAA) approving boys volleyball as a sanctioned sport last fall.

"Boys volleyball is gaining in popularity within our state," explained AC-S Athletic Director Brad Hood. "When you look around you see all of the small colleges in Kentucky are now offering men's volleyball and offering scholarships. With the interest in volleyball around here, it's a no-brainer."

After the KHSAA approved the sport, male students at AC-SH were polled to gauge interest in participating in volleyball. The results have prompted school athletic officials to move forward with fielding a varsity squad.

"When you have 50-60 kids showing interest, you start having meetings," Hood explained. "Now we are in the process of starting the sport. Probably near the first of March, we will start seeing some guy's volleyball matches."

According to the KHSAA website, 74 schools across the Commonwealth will participate in the first season of the new sanctioned sport. The KHSAA has divided the participating schools into eight regions. AC-S will be in Region 1 along with Adair County, Daviess County, Fort Campbell, Hart County, Ohio County, South Warren and Trinity (Whitesville).

Unlike girls volleyball which is played in the fall, boys volleyball will be a spring sport. Its season will be similar to baseball and softball. According to the KHSAA, teams can start practice on February 3 with the regular season stretching from March 3 through May 7. Teams may schedule 25 contests leading up to postseason play-tournament action that starts at the regional level.

The regional tournament window is May 9-12. To field a 16-team state tournament, both the region winner and runner-up move on. First round state tournament play is May 14-17 with the state semifinals and finals May 20 at George Rogers Clark High School in Winchester.

The loss locked up the District 15 tournament pairings. One-seed Barren County (14-9, 5-1) will face four-seed AC-S (8-13, 0-5). Twoseed Warren East (13-8, 4-2) will play threeseed Glasgow (3-16, 2-3). The tournament will be played the week of February 24 at Barren County.

AC-S has a busy weekend ahead with a game Friday at Glasgow and a home game Saturday at 6 p.m. against Fort Campbell (2-16).

### **LEGAL NOTICE**

#### TO ALL PROPERTY OWNERS OF ALLEN COUNTY

#### January 1 through February 28

All property held as of January 1 is subject to listing as such:

REAL ESTATE: farms, homes, city houses and lots, commercial buildings, mobile homes, etc., must be listed by FEBRUARY 28, 2025.

PERSONAL PROPERTY: merchants and businessmen's inventory or office equipment, shop tools, etc., must be listed by MAY 15, 2025.

Any person providing rental space for mobile homes is required by law to list the same with Property Valuation Administrator; the name, age and size of each unit that space is provided for. The mobile home location and the name and mailing address of the mobile homeowner.

The Kentucky Statute Sec. 132-220 requires all property owners to assess their property to the Property Valuation Administrator.

#### ATTENTION **HOMESTEAD EXEMPTION& DISABILITY EXEMPTION**

All real estate owners who will reach the age of 65 between JANUARY 1, 2025, and DECEMBER 31, 2025, if you own and occupy a house, whether in town or on a farm, you are eligible for the Homestead Exemption. This means the first \$49,100 from your assessment is exempt from taxes. To receive this exemption, you must apply in the PVA Office.

Also, if you own and occupy a house and you are not age 65 or older but you are receiving 100% total disability benefits from a Federal Government Agency, or total disability and receiving any public or private retirement system, you would also be able to receive the same exemption amount which the age 65 and older receive, but you must show proof and apply at the PVA Office.
