stop sign, first-degree possession of a controlled substance (drug unspecified), and possession of marijuana.

•Homer Burd, rear license not illuminated, operating on suspended or revoked operators license, first-degree trafficking in a controlled substance (methamphetamine), possession of marijuana, tampering with physical evidence, and first-degree persistent felony offender.

•Dillion P. Freeland, first-degree possession of a controlled substance (methamphetamine), and no operators license.

•Candace Chelsea Douglas, first-degree sexual abuse.

•Amy E. Hunt, second-degree burglary, and second-degree criminal mischief.

•Eric Wayne Key, first-degree bail jumping.

•Chase Alexander Hendley, 1st degree bail jumping, and first-degree persistent felony offender.
