Be it good home cooked meals, country ham, barbecue, catfish or crispy chicken seasoned to satisfy mouth watering appetites, Scottsville and Allen County have always been noted for fine eating. While time has erased opportunity for local chicken dining, except those modern chicken fingers, owners Teddy and Kim Pedigo along with Jack Bransford have invested in a long ago dream for providing Allen County with memorable chicken recipes available for taste buds

In 1975, residents were eager to partake in a new franchise opening known as Famous Recipe at 508 East Main Street with Campbellsville, Ky., owner Dorris Newton and manager Steve Foster overseeing more than 16 personnel.

Lee's Famous Recipe Chicken, a quick service restaurant franchise founded in 1966 specialized in chicken,

homestyle sides and biscuits. After the sale of Kentucky Fried Chicken(KFC) in 1964, Lee Cummings (the nephew of KFC founder Colonel Harland Sanders) began developing his recipe, later to be known as "Famous Recipe."

In 1983, owner John Adams dropped the franchise, yet offered the same great chicken, sides and biscuits under a new name, John's Chicken Shack.

Jack Bransford remembers his beginning in October 1982 during junior high student days with John's Chicken Shack and preparing chicken for the general public. His life has been busy with Allen County Extension Service in 1985 and then the City of Scottsville in 1989 until retiring in December 2024.

Thoughts at the time of Adams closing John's Chicken Shack did not develop into continuation of the location as a food establishment for Bransford and Pedigo due to expensive

financial investments and operations. Today, an avenue to fill an absent presence of a local chicken eatery has Jack's Chicken Shack offering the memorable chicken recipes just a short drive east of Scottsville at 6389 Brownsford Road.

Bransford related lots of changes have transpired through the years with business practices and food preparation associated with their opportunity to start the adventure. Since COVID, supplies, such as spices, are difficult to acquire as well as handling chicken safely for consumer enjoyment can be quite an undertaking also.

The investment into a food truck is allowing a greater distribution within local events, yet the current location has been sufficient to begin the business.

Menu items include livers, gizzards, chicken as well as sides and biscuits on Thursday, Friday, Saturday beginning at 10:30 a.m. to 6 p.m. or earlier if they sell out.
