An Ordinance Enacting and Adopting a Supplement to the Code of Ordinances of the City of Scottsville, Kentucky

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2024 Supplement to the Code of Ordinances of the City of Scottsville, which supplement contains all Ordinances of a general nature enacted since the prior supplement to the Code of Ordinances of this municipality; and
