CITY OF SCOTTSVILLE, KENTUCKY ORDINANCE No. 901-25

AN ORDINANCE IMPLEMENTING AN ASSET INVENTORY MANAGEMENT SYSTEM FOR THE CITY OF SCOTTSVILLE.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of Scottsvsille, Kentucky as follows:

A. All city property shall have affixed to it a property control number tag. All department heads will ensure that they maintain in their files an updated inventory of all property in their B. Once a year (preferably during the budget period) all City of Scottsville property will be inventoried by each department

or agency. These updated inventories will be submitted to the Mayor's office for reconciliation and filing. C. All city inventories shall contain an item inventory number, an item description, date of purchase if known, purchase amount

if known, and office/department/agency where the property is This ordinance shall take effect and be in force from and after

passage, approval and publication. Passed this 24th day of November, 2025.
