Free tire collection event April 24 -26

Clinton County, in partnership with the Division of Waste Management, is sponsoring a waste tire collection event to allow Kentucky residents a chance to dispose of waste tires at no charge.

This event will take place on April 24 and 25, from 7:30 am to 3:30 pm and on April 26, from 7:30 am to 12:00 noon, at the Kentucky Department of Transportation Highway Garage, located at 397 State Garage Road, in Albany, Kentucky.

Tires accepted are: tires off or on rim, farm implement, bicycle, motorcycle, go-cart, ATV, tractor, truck and passenger tires.

Tires NOT accepted are:

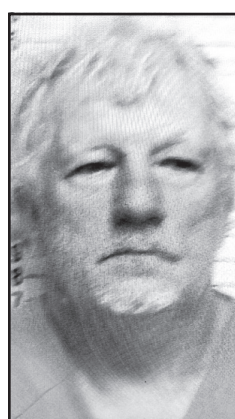
OTR-Off Road Construction, rubber tracks, sheet rubber, solid tires (with or without press-on rims), foam and calcium, or otherwise filled, any tire with a bead greater than 1 3/4 inches.

Tires will NOT be accepted from: tire retailers, agricultural retailers, scrap dealers, salvage yards or tire recyclers. 26-4

Kentucky State Police investigate murder in Wayne County

The Kentucky State Police (KSP) Post 11 London is investigating a murder in Wayne County following the discovery of a deceased man with a gunshot wound early Sunday morning.

At approximately 4:15 a.m. on March 30, 2025, KSP Post 11 London was contacted by Wayne County 911 regarding a male subject found at a Monticello residence, located on Cart Bell Ridge Road, with an apparent gunshot wound.

The Wayne County Sheriff's Office initially responded to the scene, and after determining that foul play may have been involved, requested the assistance of the Kentucky State Police to conduct a formal investigation.

The victim has been identified as 46-year-old Berry Rainer Rose III, who was found outside his home. Rose was pronounced deceased at the scene by the Wayne County Coroner's Office.

Rose is a graduate of Clinton County High School and a former resident of Albany, Kentucky.

Following an investigation, Kentucky State Police troopers located and apprehended Norman E. McGuire, a 60-year-old resident of Monticello, Kentucky, at a residence on Circle Road.

McGuire has been arrested and charged with 1st degree murder in connection to the death of Rose.

Detective Keegan Bray is leading the ongoing investigation, with assistance from KSP's Post 11 London Investigative Team, the Wayne County Sheriff's Office, and the Wayne County Coroner's Office.

The investigation is still active and further details will be released as they become available.

Business taxes can now be paid in MyTaxes

The Kentucky Department of Revenue has launched a new business tax portal. Your username was sent to you via email on March 17, 2025. Please use this information to log in to MyTaxes. Please note, your username is not necessarily your email address. If you have issues logging in, please call our Customer Contact Center at 502-764-5555 or email portalhelp@ky.gov.

Taxes that should be paid in the portal include: Sales & Use, Corporation Income (Corp)/Limited Liability Entity (LLE), Telecom, Withholding, Utilities Gross Receipts License Tax (UGRLT), Non-Resident Withholding (NRWH), Commercial Mobile Radio Service (CMRS), Tire, and Transient.

Kentucky State Police Posts 11, 15 to conduct traffic safety checkpoints

Kentucky State Police Post 11, London, and Post 15, Columbia, will be conducting periodic traffic safety checkpoints in the posts areas, which includes coverage for Clay, Laurel, McCreary, Pulaski, Rockcastle, Wayne and Whitley counties for Post 11, and Green, Taylor, Marion, Washington, Russell, Casey, Adair, Metcalfe, Monroe, Clinton, and Cumberland counties for Post 15.

These checkpoints will be conducted as part of the post's highway safety efforts.

Troopers will be checking for violations of Kentucky traffic and regulatory laws including, but not limited to, motor vehicle equipment safety, licensing of drivers, motor vehicle registration, child restraints, and operation of motor vehicle while under the influence of intoxicants.
