The Gardner School Marks 20 Years with Multi-State Expansion in 2026

Nashville, TN, Dec. 02, 2025 (GLOBE NEWSWIRE) — The Gardner School (TGS), a nationally recognized leader in early childhood education, announced a strategic expansion in its 20th year, with plans to open six new schools in 2026.

Many alumni have since advanced into rigorous academic programs, arts training, early collegiate pathways, and other opportunities that reflect the strong foundation built during their time at TGS.
