The Louisville Metro Air Pollution Control District (District) proposes to issue a construction permit to Louisville Gas & Electric Company, Mill Creek Generating Station (power plant), 14660 Dixie Highway, Louisville, KY 40272 in accordance with Regulation 2.03.
