Notice is hereby given that the City Council of the City of Marion, Kentucky, at its regular called meeting held on December 15, 2025, at 5:00 o'clock p.m., gave second reading and passed and adopted an Ordinance relating to the Marion Code of Ordinances, which Ordinance had been given its first reading at a regular called meeting of the City Council held on November 17, 2025. at 5:00 o'clock p.m. A summary of the Ordinance is as follows:

Any person, firm or corporation that damages a street or sidewalk shall be fined not less than \$50 nor more than \$500 for each offense. In addition to a fine or in lieu of a fine there may be imprisonment for not more than six months. Any other violation of Chapter 91 of the City of Marion Code of Ordinance shall be fined not less than \$200.

NOTICE OF PASSAGE AND SUMMARY OF ORDINANCE

ORDINANCE NUMBER 25-19 AN ORDINANCE AMENDING § 92.99 PENALTY FOR VIOLATION OF CHAPTER 92: NUISANCES FINE SCHEDULE

Notice is hereby given that the City Council of the City of Marion, Kentucky, at its regular called meeting held on December 15, 2025, at 5:00 o'clock p.m., gave second reading and passed and adopted an Ordinance relating to the Marion Code of Ordinances, which Ordinance had been given its first reading at a regular called meeting of the City Council held on November 17, 2025, at 5:00 o'clock p.m. A summary of the Ordinance is as follows:

In addition to the civil remedies provided for in §§ 92.01 through 92.08, it shall be unlawful for any person to continue and maintain the public nuisance as described herein, and any person violating any provisions of §§ 92.01 through 92.08 shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in any amount not less than \$50 nor more than \$500 or be imprisoned in the county detention center for a period not exceeding 30 days or be both so fined and imprisoned. Each day such violation is committed or permitted to continue shall constitute a separate offense and shall be punishable as such hereunder.

(B) Any person who shall fail to conform to the provisions of §§ 92.15 through 92.18 or violates any provisions of §§ 92.15 through 92.18 shall be guilty of a violation thereof and upon conviction in any court of competent jurisdiction shall be punished by a fine of not less than \$50 nor more than \$500 and shall be liable for the costs of prosecution for each such offense. Each day that a violation continues to exist shall be considered a separate and distinct violation.
