The bid should consist of constructing double bituminous surface treatment composed of mat courses and seal coats. A mat course shall consist of the application of bituminous materials covered with coarse aggregate, seal coats shall consist of lighter application of bituminous materials covered with fine aggregate. A double surface-treatment shall be constructed on a watered base. The County will supply the aggregate and bituminous materials. Application of seal coat aggregate shall be uniformly spread with self propelled chip spreader over the bituminous materials to ensure that the chips are being embedded in the bituminous materials while they are still at the proper temperature. When the chips have been uniformly distributed, they shall be immediately rolled with a rubber tire roller. This bid shall apply for the reminder of Fiscal Year 2024/2025, and continue throughout Fiscal Year 2025/2026.
