The Corner Butcher shop is open for business

After long months of waiting and watching The Corner Butcher take shape through the windows, residents can finally step inside. The ribbon cutting took place last Tuesday morning and then the shop opened its doors for business.

Under the ownership of the Riverview Meat Company, The Corner Butcher offers beef raised locally at Steve Judy's 4 Sons Farm and Kelli Mulberry's Headquarters Cattle Farm. There's also a plethora of pork.

The butcher counter is only

part of the operation, though; there are also cases full of fresh, ready to heat entrees and side dishes from the shop's kitchen as well as frozen options—everything from multiple kinds of quiche and meatloaves to frog legs and breaded butterfly shrimp.

There are more than a dozen soups to try—especially welcome now that the weather has turned cold.

There are several keto diet-friendly options among both the soups and entrees.

Mulberry said many of the dishes are family recipes; others are new, tested in her own kitchen.

In addition to meats and ready-to-heat meals, you can also pick up a rustic loaf of artisan bread or Stepping Stone Farm's preserves and pickles.

The Corner Butcher is located at 140 East Pike Street in Cynthiana. Hours are Tuesday through Friday, 11 a.m. to 6 p.m. and Saturday 10 a.m. to 3 p.m. The shop is closed Sunday and Monday.

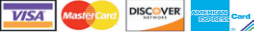
