### Dinner Ideas Ashlynne's "Chicken Roast" (Oven)

- •3–4 chicken breasts
- •2 cans French-style green beans (drain 1½ cans)
- •5-6 red potatoes, diced
- •1 onion, chopped
- ·i omon, chopped
- •1 stick butter
- •1 packet ranch seasoning

Place chicken in the center of a large baking dish or Dutch oven. Add potatoes and green beans to each side. Sprinkle with chopped onions.

Melt butter and mix with ranch seasoning, pour over. Cover and bake at 375°F for 1 hour or until chicken is done and potatoes are soft.

- •Chicken breasts
- •1 jar salsa
- Taco seasoning
- Ranch seasoning

Cook on low all day. Great in tortillas, rice bowls, lettuce wraps, or with black beans.

### Olivia's Chicken & Gravy (Crockpot)

- •1.5 lbs boneless, skinless chicken
- 4 chicken gravy packets
- •2 cans cream of chicken soup •3½ cups water
- -372 cups water

Cook on high for 4 hours. Serve with stuffing and mashed potatoes.

#### Joy's Chicken Spaghetti (Crockpot) •3 chicken breasts

- 3 chicken breast
- •1 jar marinara + 1 jar Alfredo sauce•1 block cream cheese
- 1 block cream chees
- •Garlic salt, onion powder, red pepper, salt & pepper
- •Shredded cheese + cooked spaghetti noodles

Cook on high 6 hours. Stir in cheese and noodles before serving.

### Emily's Chicken Quesadillas

- •Shredded rotisserie/boiled chicken
- •Cheese tossed with taco & ranch seasoning
- Sour cream
- Tortillas

Spread sour cream on tortilla, add chicken and cheese, grill in pan, fold, slice, serve with salsa.

### Lisa's Grilled Chicken Tacos

- Canned chicken
- Shredded cheese
- •Taco seasoning
- Tortillas

Mix chicken, cheese, seasoning. Grill like a grilled cheese sandwich.

### Michelle's Italian Chicken Bake

- •Chicken breasts
- •Red potatoes
- •Green beans
- •1 packet dry Italian dressing mix Layer in a 9x13 pan, sprinkle mix, cover and bake until done.

### Kelli's One-Pan Shrimp & Sausage

- Country-style potatoes (frozen)
- Sliced smoked sausage
- •Peppers & onions
- Frozen shrimpOld Bay, salt, pepper

Fry potatoes, add sausage and veggies, then shrimp. Season and cook until done.

### Sheena's Crockpot Manhattans

- •2 boneless beef roasts
- •2 packets dry ranch
- •2 packets au jus

The list of Certificates of Delinquency is also available for public inspection during the hours of 8:00 – 4:00 Monday through Wednesday, 8:00 – 5:00 on Friday, and 8:00 – Noon on both Thursday and Saturday at the County Court Clerk's office located at 108 N. Main Street, Brownsville, KY 42210. This list may also be inspected on the Edmonson County Court Clerk's website. The Uniform Resource locator (URL) of the website is http://edmonsoncountyclerk.ky.gov. The tax sale will be held on September 16th, 2025 beginning at 11:00 A.M. All interested participants must register with the County Court Clerk's office by the close of business on September 5th, 2025. Please contact the County Court Clerk's office if you need additional infor-mation about the tax sale registration process, the required registration fee or the deposit amounts (25% of the total value of the Certificates of Delinquencies on the list that you wish to purchase) that will be needed. Taxpayers can continue to pay their delinquent tax bills to the County Court Clerk's office any time pri-or to the tax sale. Please note: All payments must be received in the County Court Clerk's office, in full, prior to the tax sale date listed in this advertisement. Payments received after the tax sale has been conducted will be returned without exception. Some delinquencies – although they have been advertised – will be excluded from the tax sale in accordance with the provi-sions of KRS 134.504 (10)
