NOTICE OF INTENTION TO MINE NONCOAL MINERALS

Pursuant to Application Number 033-9400

(1) In accordance with KRS Chapter 350, notice is hereby given that Hinkle Contracting Company, LLC, P.O. Box 200, Paris, KY 40362, intends to apply for an amendment to an existing non-coal surface mining permit named Tipton Ridge Quarry. The permit will add 1.15 acres of Access Road to the existing surface acres. The road will be temporary, and only utilized for access to the site to perform reclamation and close out the site. No additional mining is proposed.

(2) The entrance to the site is on the South Side of KY HWY 52 (Tipton Ridge Road), approximately 0.7 Miles along HWY 52 (Tipton Ridge Road) West of the KY HWY 52 (Tipton Ridge Road) and Wagers Mountain Road intersection. The address is 1100 Tipton Ridge Road (KY HWY 52), Ravenna, KY 40472. The latitude of the mine entrance is 37 degrees 42 minutes 34 seconds. The longitude of the mine entrance is 83 degrees 53 minutes 38 seconds.

(3) The operation is located on the Irvine, KY U.S.G.S. 7½ minute quadrangle map. The operation is in Reclamation Only Status.

(4) The application will be on file for public inspection at the Department for Natural Resources Frankfort Office, 300 Sower Boulevard, Frankfort, KY 40601. Written comments, objections, or requests for a permit conference must be filed with the Director, Division of Mine Reclamation & Enforcement, 300 Sower Boulevard, Frankfort, KY 40601 within 15 days of this advertisement and briefly summarize the issues to be raised at the conference.

LEGAL NOTICE The Kentucky Transportation Cabinet

In accordance with KRS 176.051, Kentucky's noxious weed law, the Kentucky Transportation Cabinet will control noxious weeds on state-owned right of way at the request of the adjoining property owner. The noxious weeds named in this law are Johnson grass (*Sorghum halepense*), Canada thistle (*Cirsium arvense*), Cutleaf Teasel (*Dipsacus laciniatus*) Nodding thistle (*Carduus nutans*), Common teasel (*Dipsacus fullonum*), Poison hemlock (*Conium maculatum*), Marestail (*Conyza canadensis*), Amur Honeysuckle (*Lonicera maackii*), Multiflora Rose (*Rosa multiflora*) Japanese knotweed, (*Polygonum cuspidatum*), Spotted Knapweed (*Centaurea stoebe*) and Kudzu (*Pueraria montana*).

Persons who own property adjacent to state right of way and who are involved in eradication efforts on their property can submit a written application to the highway district office in their area. Contact information can be found at transportation.ky.gov/DistrictPages
