HEAT Plastic == Seeds

Place potting soil in a small container. Moisten the soil well, but do not soak. Place seeds just below the surface of the soil, and cover the container with clear plastic,

Germination or insert it into a plastic bag, without letting plastic rest directly on the soil. This helps the soil retain moisture and heat. Place under a lamp for warmth, and keep the

soil moist by "misting." As your sprouts appear and grow, remove plastic. Mist daily and keep sprouts warm until you are ready to transplant


