# River Counties Drug, Violent Crimes Task Force make arrest

On April 15th, the River Counties Drug and Violent Crimes Task Force executed a search warrant in the 100 block of Bernal Avenue in Hickman. As a result of the search warrant, in excess of 4 ounces of methamphetamine was located. Powder cocaine, crack

cocaine, oxycodone, marijuana, methamphetamine smoking pipes, digital scales and baggies were also located, as well as four handguns. More than \$3,000 cash and two vehicles were also seized during the search warrant. The Task Force was as-

sisted on scene by Hickman City Police Department. Arrested was Kenyon L. Pierce, age 60, of Hickman. He was charged with: Trafficking in Controlled Substance 1st Degree 1st Offense > 2 grams (Methamphetamine); Trafficking

in Controlled Substance 1st Degree 1st Offense > 4 grams (Cocaine); Trafficking in Controlled Substance 1st Degree 1st Offense > 10 dosage units (Opiates); Trafficking in Marijuana < 8 ounces; Possession of Drug Paraphernalia. All charges were firearm enhanced.

# Local agencies conduct search warrant

On April 17, Fulton County Sheriff's Office, along with Hickman Police Department and Hickman County Sheriff's Office conducted a search warrant at 350 Bernal Ave. in Hickman, also known as Indian Hills. During entry of the home
