

Planting by the Signs *April Overview* by Phil Case

PBTS NOTE: For the past few months, we've been idling along waiting for the weather to improve. We have endured the snow and ice of January and February and now here in late March gardening season has arrived along with Spring – and I know the early gardeners are already at it, planting those veggies that like cool weather and soil and can endure frost. Many of us are starting seed to grow transplants for our warm-weather gardens.

Here is the remainder of March and early April's information. Please listen to the weather reports, make sure your ground is dry enough for planting – which can be a challenge – and, of course, follow the phases and signs. If you have questions, my contact info is at the end of this column.

QUICK TAKES

REST OF MARCH: Make changes through most of March 27; March 26-27: VERY fertile, Pisces/feet, below-grounders; March 28-29: no planting, killing sign Aries/head rules; March 29: New/light moon comes to rule, 6:58 a.m., abovegrounders until full moon on April 12, 8:22 p.m.; March 30-31: VERY fertile, Taurus/neck , abovegrounders.

APRIL: April 1-2: Gemini/arms, pea/bean sign, read more below; April 2-4: Cancer/breast, VERY fertile, abovegrounders; April 6-7, no planting, killing sign Leo/ heart in force; April 8-12: flowering signs Virgo/ bowels (2), Libra/reins (3), flowers only/bloom days.

grounders, and five with the light moon in force for above-grounders.

KILLING DAYS: Leo/heart, April 6-7; and Aries/head, April 25-26. There are only four days ruled by the two killing signs during April, down from seven in March and the absolute minimum.

FLOWERING DAYS: Virgo/bowels, 8-9; and Libra/reins, April 10-12.

FERTILE DAYS: Sagittarius/thighs, April 15-17; Capricorn/knees, April 18-19; and Aquarius/legs, April 20-22. There are eight days in April ruled by these three signs, all with the dark moon ruling. Almost impossible to have any more than that! These are all great for belowground producers.

MAKING CHANG-ES: We have 10 days to make changes! They are April 15-24 with the signs going out of the body beyond anything that functions and the moon in the dark phase, specifically Sagittarius/thighs, Capricorn/knees, Aquarius/legs, and Pisces/feet. Changes might include starting a diet or exercise program, stopping smoking or other unhealthy habits, weaning small children or animals, scheduling elective surgery or dental work – anything requiring us to do something differently from the way we are doing it now.

POURING GRAVEL: If you have gravel to pour on a drive or road on your farm, do that while the light moon rules, which is through most of April 12. After that wait until the new moon arrives on April 27th through May 11th.

OTHER NOTABLE APRIL DAYS: Dr. Martin Luther King assassinated, 4th; Hank Aaron hit his 715th home run, 8th; Passover begins at sundown, 12th; Palm Sunday, 13th; tax day since 1955, 15; Easter, 20th; Chernobyl disaster, 26th.

MOON PHASES: April begins with the moon in the light phase where it continues until the full/dark moon at 8:22 p.m. April 12. The new/ light moon returns April 27, 3:31 p.m. When the light moon

is in force, plant aboveground producers and it's below-ground producers when the dark moon rules.

Don't plant when either of the killing signs, Aries and Leo, is in force or veggies when the flowering signs Virgo and Libra rule since they are bloom days.

Planting when the fertile signs rule is a viable alternative to the VERY fertile signs, which are Scorpio, Pisces, Taurus, and Cancer. The fertile ones – just a little below VERY fertile - are Sagittarius, Capricorn, and Aquarius.

If you can only utilize one aspect of the system for planting, I would suggest going with the moon phases but still completely avoid the killing signs Aries and Leo and the flowering signs Virgo and Libra for anything but flowers.

THE SIGNS: Check to see if the moon is in the light or dark phase (information above and on any calendar) before planting anywhere, or other moonrelated activities. April begins – and ends – with Gemini/arms, the pea/ bean signs ruling, that's where we will start.

PEA/BEAN DAYS: Gemini/arms, April 1-2, 29-30, snow peas on the early days (1-2); on the late days (29-30) it will be statistically fine for an early planting of bush or pole beans and on the
