ORDINANCE NO. 2025-004

AN ORDINANCE OF THE CITY OF GLENCOE, GALLATIN COUNTY,
KENTUCKY, ADOPTING THE ANNUAL BUDGET THEREOF FOR THE
PERIOD OF JULY 1, 2025 THROUGH JUNE 30, 2026 BY ESTIMATING
REVENUES AND APPROPRIATING FUNDS FOR THE OPERATIONS
OF CITY GOVERNMENT.

WHEREAS, an annual Mayor's state of the City and budget message has been presented
to the Glencoe City Council by the Mayor; and

WHEREAS, the Glencoe City Council has reviewed the proposed Annual Budget, made
all necessary or advisable modifications, and approved said Budget estimating revenues and
appropriating funds for the operations of the City government; and

WHEREAS, the Glencoe City Council has determined that the Budget for the Fiscal
Year 2025-2026, attached as an Exhibit hereto be adopted by the City of Glencoe

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
GLENCOE, GALLATIN COUNTY, KENTUCKY, AS FOLLOWS:


SECTION 1: That the annual budget for the fiscal year beginning July 1, 2025 and
ending June 30, 2026, as set forth in the attached Exhibit A, which is incorporated by reference
as if fully stated herein, is hereby adopted as the annual budget for the City of Glencoe,
Kentucky.

SECTION 2: This Ordinance shall be effective as of its adoption and publication
according to law.

SECTION 3: The invalidity of any section of this Ordinance shall not affect the validity
of any other section.

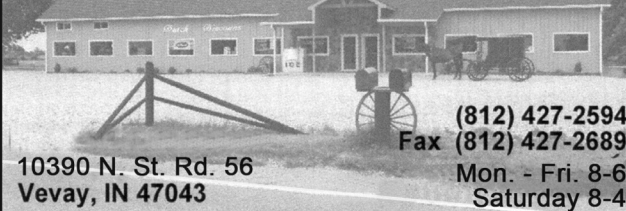
