#### SECTION THREE

Provides that all ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

#### AMENDING SECTION 2-60 OF THE CODE OF ORDINANCES REGARD-ING PERSONNEL.

SUMMARY

1. Amends "Exhibit B" of Section 2-60(c) of the Code of Ordinances to: increase the number of Permit Technician positions from 1 to 2 within the

number of Police Captain positions from 1 to 2 and the number of Police Officer positions from 57 to 59, as well as to change the grade of the Body Worn Camera Program Coordinator from Grade 104 to Grade 108, within the Georgetown Police Department; increase the Code Enforcement Officer positions from 1 to 2 within the Georgetown Fire Department; and create 1 Coordinator position and change the title of the Assistant Manager position to Assistant Coordinator within the Georgetown/Scott County 911 Center.
