General fund rate adopted at August 28 Board of Education meeting

The Scott County Board of Education held a public hearing at 2168 Frankfort Road in Georgetown, Kentucky on August 28, 2025 at 6:00pm to hear public comments regarding a proposed general fund tax levy of 62.9 cents on real property and 62.9 cents on personal property.

At a meeting of the Scott County Board of Education on August 28, 2025,

a General Fund rate was adopted.

The Scott County Board of Education has adopted a General Fund rate of 62.9 cents on real property and 62.9 cents on personal property. Of the real property rate, 1.2 cents is subject to recall.

There is no change in the General Fund rate from fiscal year 2025 to fiscal year 2026. The General Fund tax levied in previous fiscal year 2025 was 62.9 cents on real property and 62.9 cents on personal property.
