**NOTICE OF BOND RELEASE**  
In accordance with KRS 350.093, notice is hereby given that ERP Environmental Fund, Inc. (ERPEF), 216 School Drive, Shrewsbury, West Virginia 25015, has applied for Phase I bond release on Increment 6 of Permit No. 851-0054, which was last issued on 27 May 2025 (Permit 851-0054 MT-05). The bond release application covers a total area of 87.4 acres, located approximately 0.6 mile south of Hebbardsville in Henderson County. The permit area is located approximately 0.6 mile south of the KY 351 junction with KY 416 at Hebbardsville, and one-half mile east of Lick Creek. The bond now in effect for Increment 6 is Bond #N-062017-851-0054-06 in the amount of \$255,300. Approximately 61.4% of that current bond amount (\$156,800) is included in the application for release. That amount also includes 100% bond reduction on 3.9 acres undisturbed area. For the Phase I release on Increment 6, the following steps have been completed: Completion of backfilling, regroding, topsoil replacement, and drainage control including soil preparation and seeding and mulching have been accomplished in accordance with the approved reclamation plan for this increment. These reclamation requirements were completed in September 2022. Written comments, objections, and requests for a public hearing or informal conference must be filed with the Director, Division of Mine Reclamation and Enforcement, 300 Sower Boulevard, Frankfort, Kentucky 40601, by Monday, 25 August 2025. A public hearing on the application has been scheduled for Tuesday, 26 August 2025 at 9:00 A.M. at the Kentucky Department for Natural Resources (KDNR), Madisonville Regional Office, 625 Hospital Drive, Madisonville, Kentucky 42431-1683. The hearing will be cancelled if no request for a hearing or informal conference is received by Monday, 25 August 2025.
