

# Detritus to treasure

Life hands us a lot of detritus, bits of paper that we keep, thinking "I might want that one day." Many times these bits—recipes, receipts, ticket stubs, greeting cards—wind up as my bookmarks. I'll come across them years later and they serve as little reminders of the past.

Recently, I came into possession of a notebook that belonged to my maternal grandmother, Mattie Louise Petty Brannock, who was a student at Berry High School in the 1930s. Except for the fact that the black binder has only two rings instead of three, it resembles the notebooks I used decades later.

In addition to her neatly written class notes and spelling tests, tucked inside the binder are loose items that provide little glimpses of her life.

- There's a full-page advertisement on blue paper for Blue Jay school and stationary supplies. The company made everything from notebook paper to steno pads to music tablets. Each item had a little blue jay image to cut out and save.

When you collected enough blue jays, you could send them in to claim a "beautiful premium," such as a pocket knife, a fielder's glove or a compact. For 500 blue birds, you could claim a Shirley Temple doll or an "exquisite toilet set."

500! How much writing did this company think kids were going to be doing? (The offer expired June

30, 1938, so it's too late to take advantage of it.)

- There's a little tiny cardboard tag from a 4-quart Presto pressure cooker. The back of the card lists "ceiling price \$12.50" and a separate "ceiling price western zone \$12.95" along with the notice "The prices above have been fixed as the minimum prices at which 4 qt. Presto cookers may be sold in all states having fair trade laws."

I never saw anything like that before, but it applied to 11 western states "and following Counties in Texas: El Paso, Hudspeth, Culbertson, Jeff Davis, Presidio, Brewster, Terrell, Pecos, Reeves."

- There's a blank Union Bank of Berry check that is a thing of beauty—proud lettering, a handsome engraving of the bank building in the top left corner where, in later decades, the account holder's name and address would go.

Today, physical checks are rare and often of the type spit out by a machine—the kind that must be wrested free from their many-layered paper cocoons before they can be deposited. They're ugly and charmless and, no matter how careful I am when trying to free one, when I'm done the jagged, ripped edges look like a toddler got hold of it.

On the back of the blank check in Granny's binder—in someone else's handwritings—is a recipe calling for 10 ounces of whole milk, six ounces of boiled water and one ounce of sugar. The recipe is for "formula" for feeding a baby; three

ounces at each feeding, six feedings in 24 hours.

My dad was born in 1941. I imagine an older woman, on learning of my grandmother's difficulty feeding him, jotting down the recipe on the back of that check while at church or in Brannock's Store in Kelat.

- There's a small, undated brochure distributed by Farmers National Bank encouraging the purchase of war bonds and stamps, American Express money orders and Travelers' Cheques. It features illustrations of insignia of the Army, Navy and Marine Corps. (The Air Force was not created until 1947.)

"American Express money orders are ideal gifts for boys at Camp," the brochure suggests.

The detritus in Granny's notebook has been like opening a time capsule for me. The presence of those odd bits in her ring binder prove that she must have found use for her home economics notes long after she graduated from Berry High School.

The notes kept in my grandmother's binder demonstrate that her education both broadened her horizons (another column for another day) and helped prepare her for later milestones of her rural Kentucky life: marriage, house-keeping and rearing a family.

The detritus collected in the binder goes to show that even the most insignificant bit of trash can one day be a fascinating clue to the past.
