Guest speaker Shelia Wilkinson, 4th District KRTA president, reported that health insurance for retired teachers over age 65 will have nationwide HUMANA Medicare Advantage PPO plan. Copays, Out-of-Pocket, and Deductibles remain the same as 2025. It's a passive year, so nothing needs to be done regarding enrollment. You will receive a booklet from Humana in the mail and new cards before the new year. Any doctor or facility who bills Humana will accept our coverage*. * (Please note that Graves-Gilbert Clinics in the Bowling Green area just announced they will not provide coverage for Humana Medicare. Hopefully negotiations will resume to rectify this.)

Retired teachers under age 65 also have a "passive" enrollment via Anthem, and

only changes of level of plan require new enrollment. Prescription service for both Humana (Express Scripts) and Anthem (CVS Caremark) remains the same for 2026. Senate confirms Meredith for federal judgeship

U.S. Sen. Mitch McConnell (R-KY) released the following statement Thursday on the Senate's confirmation of Chad Meredith, of Lexington and the son of state Sen. Steve Meredith, R-Leitchfield, to serve on the United States District Court for the Eastern District of Kentucky.

"Congratulations to my friend and fellow Kentuckian Chad Meredith on his confirmation to serve as a district judge for the Eastern District of Kentucky," said McConnell. "Chad's impressive legal background in the private sector and devotion to serving the public make him an excellent addition to the federal bench. His thoughtfulness and commitment to our Constitution will serve him well as he carries out his new duties."

McConnell recommended Chad Meredith to the White House for the position of United States District Judge for the Eastern District of Kentucky. He was nominated by President Donald Trump on June 18. On July 30, McConnell delivered remarks before the Senate Judiciary Committee in support of his nomination.

Chad Meredith was confirmed by the U.S. Senate on Thursday, according to a press release from McConnell's office. He previously served as Kentucky Solicitor General from 2019-2021, as well as the Chief Deputy General Counsel to former Gov. Matt Bevin from 2015-2019.
