

3 face drug charges

Three individuals are facing charges including drug trafficking after allegedly being found in possession of suspected fentanyl, methamphetamine and drug paraphernalia.

Vina Huff, 48, Robert Allen, 51, both of Evarts, and Wilburn Madon, 42, of Verda, were arrested by the Harlan County Sheriff's Office on Aug. 16.

According to a press release, Harlan County Sheriff's Deputies arrived at a residence in the Verda community on Friday, Aug. 15, to execute a search warrant. The search of the property located a large amount of suspected fentanyl, methamphetamine, drug paraphernalia associated with drug trafficking, multiple firearms, and cash.

The case remains under investigation. Additional arrests are pending.

Huff was charged with trafficking in controlled substance (carfentanil of fentanyl derivitives), first-degree trafficking a controlled substance (methamphetamine), third-degree trafficking a controlled substance, possession of drug paraphernalia, possession of a firearm by convicted felon, and possession of a handgun by a convicted felon. Huff was lodged in the Harlan County Detention Center.

City performs first reading of tax ordinance

The Harlan City Council performed a first reading of the city's real property, personal property, and motor vehicle tax ordinance for 2025 during the council's regular August meeting.

City of Harlan Mayor Joe Meadors brought the matter to the council's attention early in the meeting.

"The other taxing authorities all over the county, their assessments went up," Meadors said. "The total assessments of real, personal and motor vehicle, ours did go up maybe \$300,000...the real property went up about \$700,000 or \$800,000 in the city. So, our tax rates last year were real property .460 cents (per \$100 of assessed value), personal property was .4879 cents (per \$100 of assessed value), and the motor vehicle was .32 cents (per \$100 of assessed value)."
