"I'm not asking to put in entire houses, I'm asking to put in footers and blocks," Sims said. He said he was trying to avoid more delays.

Shawn Moore said Sims could be limited to footers and blocks until the street was paved. The commission approved installing the footers and blocks prior to road being constructed.

• Discussed issues with subdivision regulations concerning additions. According to the agenda, site plans are needed for additions that are 200 square feet or 10 percent of the current structure, whichever is less.

"This will bring us up to what we've actually been doing in the past," Upchurch said.

What's the purpose of this if it doesn't encroach on the building setbacks?" asked Commissioner Jonathan Elliott. "Isn't that covered by the building permits?"

Upchurch said it brings planning and zoning in compliance with the building inspector's office.

'We've had several people trying to circumvent the requirements by not getting the site plans," Upchurch said. "It only applies to com-

Moore stipulated. "Any commercial or industrial has to be inspected."

Moore said it also applies to storage structures. Zoning ordinances require a building permit. The former exemption does not exclude a building permit.

The commissioners took no further action until the regulations had been drafted.

"There will be actual text for you to look at," Attorney Henry Smith said.
