fast enough to qualify for the state meet. Both Jordan and Ralasia Piazza claimed the top spot in the triple jump competition. Jordan's leap of 41'6" puts him in the position to challenge for points in Lexington, and Ralasia's mark of 35'7" puts her in a great position to

improve on her third place finish last June at the state meet, when she jumped 34'5." R. Piazza's high jump mark of 4'8" placed third, but was high enough for the junior to qualify for state in a second event.

Eighth grader Cardin Sickles placed third in the

100-meter dash with a time of 13.53. The top two finishers in each event qualify for the KHSAA state track and field meet, accompanied by the next 10 fastest competitors across the state. The final determination of which athletes qualify for state will be announced today, Thursday, May 22, given that all regional meets have been completed. The Lady Titan 4x200m relay squad, composed of R. Piazza, Lilly Hart, Grayson Perry and Sickles, qualified for state with a second-placed finish behind Boyle County, completing the relay in 1:55 seconds. The boys ran a similar race in the following event. Sanders, Alcorn, J. Piazza and Mijaia Dunn finished just fractions of a second behind the Boyle County 4x200 team, finishing the 800 meters in just 1:32.76, a seasonal high for the team.

Senior M. Hart likely qualified for state with a third-placed finish of 4:40.97 in the mile run, and freshman Ashton Butler, who has consistently run faster times throughout the season, placed sixth with a time of 4:53.74. Butler

set a personal best time of 10:44.64 in the two-mile run, placing fourth overall. L. Hart's fourth-placed finish of 1:08.36 in the 400-meter race is just on the verge of qualifying for state. Senior Krish Patel is in a similar situation; his time of 53.98 was good enough for fourth, and he's hoping it makes the cutoff. Makinlee Moore's blazing speed in the 300-meter hurdle race shocked the crowd. Despite only being in the seventh grade, Moore's personal best time of 51.78 finished second only to Kylie Clem of Corbin, who is separated by more than five years of age with Moore, but only .41 seconds on the track.

Sanders displayed great pace and discipline in the 800-meter race. His personal best time of 2:02.65 beat out runners from Corbin and Boyle County down the stretch to qualify for state. The Titans claimed arguably the most important event at any meet. The team of Sanders, Patel, Dunn and Alcorn dominated the mile relay with a blazing time of 3:32.30.

In addition to their impressive performance

on the track, Mercer had a top-two finisher in nearly every field event. Dunn set a personal record distance of 20'8" in the long jump, placing second and earning himself a spot at the state meet. Moore finished third in the girls' long jump event with a leap of 15'7." Sophomore Noah Nichols

continued to dominate in the throwing ring, first winning the shot put event with a personal record throw of 53'7.75" before claiming the discus competition with an incredible 157'2" attempt. Nichols is the favorite in both events at the state meet.

the top of the first ended with a Colson Fogg strikeout. East Jessamine senior Caleb Cadle walked to first to start the Jaguars' day at the plate, and soon stole second base. Cadle put himself in position and an outfield error gifted him a scoring opportunity moments later.

Mercer responded in the top of the third inning. The Titans drew eight total walks in the game and Doughty's at bat led to their opening run after a passed ball allowed the junior a free run at home plate.

A similar situation led to the Titans' second run. Despite Cadle trying to pick off Doughty at first base four different times, the junior was determined and eventu-

ally stole second base. Five pitches later, he turned on the jets and slid into third. Despite all three other Mercer batters striking out, Doughty made the best of the situation and took home again after a wild pitch.

Mercer led 2-1 heading into the bottom of the fifth inning, but Cadle was ready for any opportunity to make up for his mistake on the mound. After a dropped fly ball allowed a Jaguar runner on, Cable smacked a hard ground ball past second base, tying the game at 2-2.

With momentum on his side, Cable returned to the mound and struck out three Mercer batters at the top of the sixth inning. He ended the game with 10 strikeouts

in four innings.

There were very few opportunities to score in a great display of pitching from both squads. With Ayden Stephens on the mound, Mercer continued to frustrate East at the plate. The Titans took a 3-2 advantage in the top of the eighth inning thanks to a blistering hit from Devine. The junior's ninth extra base hit of the season came at a pivotal moment and scored Brady Payton to reclaim the lead.

Unfortunately for the Titans, fate was not on their side. After Payton covered a ground ball for the first out, the Jaguars earned back-to-back singles and were in a prime position to take the lead. A moment later, Jaguar senior Peyton Musick collected his first hit of the game, which proved to be the most important one. One runner scored, and an error getting the ball in from left field allowed the runner from first to reach home, ending the game in the Jaguars' favor, 4-3.

It was a disappointing ending to the season, but Head Coach Cody Christopher made sure to let the class of 2025 know how much they meant to the program. Brayden Campbell, Andrew Tatum, Colson Fogg, Marshall Hart and Landon Gonzalez were freshmen when Christopher arrived in Harrodsburg, and according to the skipper, they have laid the groundwork for a prosperous future.

"They're a great group of kids, and we would go to battle with them a million more times if we could," said Christopher.
