

Four inducted into Mercer **County Fair & Horse Show** Hall of Fame

In a heartfelt ceremony held Saturday evening in center ring, four pillars of the Mercer County Fair and Horse Show were officially inducted into the Mercer County Fair & Horse Show Hall of Fame. The celebration, set against the golden sunset and the pageantry of the historic horse show, honored Bob Martin, Johnnie Slone, Gene Wright and Brad Noel for their decades of dedication to one of Kentucky's most beloved traditions.

Bob Martin, the legendary voice and heart behind WHBN Radio, was honored posthumously for his trailblazing coverage of the fair. Martin

Harrodsburg still hasn't signed contract with Republic

The City of Harrodsburg has yet to sign a contract with Republic Services.

City Attorney Norrie Currens stated that the city has yet to sign the contract with Republic, following concerns raised about the company's inconsistent information regarding the 20 percent senior discount.

"We have been forwarding the complaints we're receiving," Currens said on Monday. She said the city is refusing to sign the contract until the issues have been resolved.

In April, the Harrodsburg City Commission voted to the city for the remaining part

Republic Services, with Republic billing customers directly starting July 1. Only two companies bid for the contract, Republic and Rumpke, and Currens said the reason the city commission chose the winning bidder was that Republic offered a 20 percent senior's discount, while Rumpke offered a 5 percent discount. Even though the Harrods-

burg Herald first reported on the changeover in May and city officials began handing out information at city hall and posting notices on social media, many customers were surprised in July to receive bills for trash collection from

renew their agreement with of the billing cycle and receive a bill from Republic charging them for an entire quarter, from July 1 through Sept. 30.

At a special-called meeting earlier this month, Commissioner Charlie Mattingly stated that Republic was providing customers with different answers, telling some who called that if they had two cans, they would not receive the discount.

'That is the issue causing the most confusion," Currens said Monday.

She said if the city and Republic are unable to come to terms, "We'll be looking at other alternatives."

Currens said most citizens

Federal jury awards former firefighters \$1 million in wrongful termination suit

A federal jury has awarded \$1 million in damages to two termination.

On July 18, Judge Robert E. Wier of the of United States District Court Eastern District of Kentucky ruled in favor of Lt. Jamie Botformerly of the Harrodsburg Fire Department, in their suit against the city for wrongful

termination and deprivation of rights. Bottom and Steele were each awarded \$500,000 in compensatory damages in the judgment.

County removes lot size from agricultural noise exemption

The Mercer County Fiscal Court gave a second reading to an amendment relaxing lot size restrictions for exemptions for noise from agricultural production. Even after some residents spoke against voting to ease the restrictions, the fiscal court voted unaniproperty zoned agriculture-A-1, A-2 and A-3—regardless of lot size.

At the fiscal court's regular meeting on Tuesday, July 29, the public was given a chance to speak with a threeminute time limit.

The first speaker, Hope

Bault, stated that she had lived in Mercer County for over 23 years. Bault said a grain bin and drier had been installed near her home in 2023 that produces noise "comparable to a jet engine."

She said the noise cannot be escaped even with the windows closed. Bault said she and other neighbors had asked to implement a solution.

"These offers have been mously to exempt noise on all refused and or ignored," Bault

The current ordinance, which Bault said offered inadequate protection, "could at least allow for adequate sleep."

She said removing the lot size requirement would allow
