

After graduating from Harrodsburg High School she attended Vanderbilt University nursing school. While working in the Vanderbilt Hospital she met a young intern, Dr. Guy Nelson Copeland Jr. Marie and Nelson married Aug. 5, 1961. Marie happily accompanied Nelson to several locations over the next seven years as he completed his medical training: Memphis, Tenn., Chicopee, Mass. (Westover Air Force Base), and Durham, NC. A Public Hearing will be held Monday, December 29th, 2025 at 9:00 a.m. in the Harrodsburg City Commissioner's meeting room (second Floor) at 208 S. Main St.

This hearing is being held by the Mercer County Joint Planning & Zoning Commission for the purpose of considering public comment on several proposed text amendments regarding Conditional Use Permits to the Mercer County and City of Harrodsburg Zoning Ordinances. The proposed changes for Mercer County include revisions to Sections 6.3(A)(iii), 6.3(B) (iii), and 6.3(C)(iii). The proposed changes for the City of Harrodsburg include revisions to Sections 6.1.2, 6.2.2, 8.1.2, 8.2.2, 8.3.2, 8.4.2, 9.1.2, and 9.2.2.

Comm. missioners discussed several possible options for Lions

Park, including selling it.

Commissioner Marvin "Bubby" Isham handed out estimates for demolition, utility, and repair costs for the community center. According to the handout, electricity at the community center costs more than \$23,000 in 2025, and cleaning the facility after rentals costs more than

The capital outlay for the HVAC system at Lions Park is estimated at more than \$115,000, while the roof outlay would be more than \$175,000, according to the information.

To cover those expenses, the city would need to raise the rental rate from \$325 a day to \$1,020.71 a day, based on an average of eight rentals per month. At Monday's meeting, Chief Administrative Officer Stacey Maynard called the numbers "hypothetical" and noted they did not cover the cost of repairing the interior issues at Lions Park.

Commissioner Isham suggested putting Lions Park on

hold and doing more research. "We've had a lot of interest from people in buying the property," Isham said. He suggested getting a realtor involved.

"Is it something that we want to sell?" Mayor Bob Williams asked.

Commissioner Charlie Mattingly said he thought selling Lions Park for a fair price was a better option. "I think that would be bet-

ter all the way around," Mattingly said. Kerry Commissioner Anness agreed that selling the

property would be a better option than demolition. "We're not out \$36,000 to

tear it down," Anness said. "That would be an option I would seriously consider." At Williams' suggestion,

the commission tabled it until their meeting on Monday, Jan. 12, 2026.

'We need to do some more due diligence about that," Williams said.

As to the former HPD headquarters on Greenville Street, the commissioners agreed it needs to come down.

"We're going to need the room that adjoins the cemetery," Isham said. He recommended using the property for future grave sites.

Isham said the HPD building has "been in bad shape for years." He said it was built as the home for the Mercer County Health Department in the 1950s. Isham called it a concrete building on a concrete lot that had been subsequently bricked over.

'You couldn't go in there and remodel it like you would a house," Isham said. He noted the HVAC hasn't been run since the HPD moved to their new headquarters on U.S. 127. Isham said he would like to hold off demolition until the beginning of February, until they made sure everything had been cleaned out of the build-

"I believe that's the right way to go," Mattingly said Monday. "That building needs

to come down."

Mayor Williams said he didn't think it was "economically feasible" to repair the building.

Eight contractors bid for the demolition contract. The city will verify that the bidders have the required insurance and licenses. The building has to be surplussed by the city before it can be torn down. The commission will revisit the issue on Jan. 12.
