Raiders Open Season With 1-1 Tie

The Hart County High School 2025 Raider Soccer team and Coach Jeremy Johnson have 9 seniors listed on their KHSAA roster. The seniors are: Jack Baird, Gavin Clymer, Maddox Gower, Dawson Harl, Eli Matthews, Alexander Reynolds, Brayden Reynolds, Jacob Shoulders, and Cheston Sexton.

Coach Johnson has had these seniors for the past several years and has watched them grow in skill. Season after season, the Raider seniors set the tone for how the Raiders perform as a team. Coach Johnson always has them in shape and he uses his bench wisely in rotating his players out to protect them in the wicked August heat and also for strategy against their opposition.

The HCHS Raiders opened the 2025 season with a 1-1 tie against the Barren County Trojans. With just two minutes into the contest, Alexander Reynolds, one of the

team captains, scored a goal for the Raiders. Senior Maddox Gower was credited with an assist.

The Raiders had several more opportunities on goal, but just could not slide one in the net for the remainder of the match.

Meanwhile, senior goalkeeper, Dawson Harl, did a masterful job on the defensive end for the Raiders. Harl had 12 saves against the one Trojan goal. Harl made one great save in the first half when he deflected a shot from the Trojans at close range with his outstretched arm.

Senior Jax Stephens scored the one Trojan goal with an assist from sophomore Ryder Depp.

The Raiders dropped their second match of the year last week, falling to Franklin-Simpson 6-1.

At the time of sale the successful bidder shall either pay full cash or make a deposit of 10% of the purchase price. A Loan Officer from the pre-approved Kentucky Bank must sign the surety bond at the sale. In the event the successful bidder is the Plaintiff, then in lieu of the deposit, that Plaintiff shall be allowed to bid on credit up to the judgment amount. NO FAXED OR EMAILED BIDS WILL BE ACCEPTED.

The buyer will be responsible for taxes for the year of the sale. The property shall be sold free and clear of all parties named in the above-styled action, but subject to the following: any lien not included in the suit, recorded easements, rights of way, any facts which an inspection or accurate survey might reveal, and the planning and zoning regulations of Hart County, Kentucky. The Master Commissioner does not obtain title inspections or investigate for further liens on the property.
