### TITLE AND SUMMARY OF **ORDINANCE 09-2025 AMENDING THE 1985 ORDINANCE DATED DECEMBER 3** CITY OF MUNFORDVILLE, KENTUCKY

### **TITLE**

AN ORDINANCE OF THE CITY OF MUNFORDVILLE, KENTUCKY, AMENDING AND CLARIFYING RESTRICTIONS ON THE LOCATION AND USE OF MOBILE HOMES, HOUSE TRAILERS. TRAVEL TRAILERS, CAMPERS, MOTORHOMES, AND AUTOMOBILE TRAILERS WITHIN THE CITY LIMITS AND PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE BY SUMMARY.

### **SUMMARY OF ORDINANCE**

The City of Munfordville has adopted Ordinance 09-2025, amending its December 3,1985 ordinance regulating trailers and mobile homes. The ordinance prohibits the use of mobile homes, house trailers, travel trailers, campers, and motorhomes as dwellings within city limits, except for limited camping at Thelma Stovall Park. Overnight camping is allowed for one (1) night without approval; longer stays require prior approval from City Hall. Violations are subject to civil penalties ofup to \$100.00 per day and removal of unauthorized vehicles

All prior ordinances or parts thereof in conflict with this ordinance are repealed to the extent of any such conflict.

This ordinance shall take effect upon its adoption and publication.


