TITLE

AN ORDINANCE OF THE CITY OF MUNFORDVILLE, KENTUCKY, AMENDING CERTAIN ARTICLES OF ZONING ORDINANCE NO. 13-2021, INCLUDING REVISIONS TO THE QUALIFICATIONS AND APPOINTMENT OF MEMBERS TO THE MUNFORDVILLE BOARD OF ZONING ADJUSTMENT, UPDATING SEWERAGE DISPOSAL REQUIREMENTS FOR BUILDINGS, REVISING TEMPORARY POLITICAL SIGN REGULATIONS, AND MODIFYING BILLBOARD REGULATIONS FOR SIGNS EXCEEDING 200 SQUARE FEET AND DIRECTING PUBLICATION BY SUMMARY.

SUMMARY OF ORDINANCE

The City or Munfordville has passed an ordinance amending several sections of Zoning Ordinance 013-021. The ordinance revises Article 2.12 regarding the qualifications of who can serve and the appointment or members by the Mayor with approval of the City on the Munfordville Board of Zoning Adjustment.

The ordinance further amends Article 4.1.4 to update sewerage disposal requirements for buildings, including mandatory connection to accessible public sewer lines, updated distance requirements and includes any exemption must be approved by the City Council.

Amendments to Article 5 revise temporary political signage rules, including permitted dates for placement and removal, and update regulations governing billboards exceeding 200 square feet.

All ordinances or parts thereof in conflict with this ordinance are repealed to the extent or such conflict. This ordinance is effective upon adoption and publication.

AN ORDINANCE OF THE CITY OF MUNFORDVILLE, KENTUCKY, AMENDING ORDINANCE 02-2021 RELATING TO THE REGULATION AND LICENSING OF BUSINESSES OPERATING WITHIN THE CITY; REVISING CERTAIN DEFINITIONS; ESTABLISHING AN UPDATED FEE SCHEDULE; AND PROVIDING FOR ENFORCEMENT PENALTIES, AND DIRECTING PUBLICATION BY SUMMARY

SUMMARY OF ORDINANCE

The City of Munfordville has enacted Ordinance No. 08-2025 amending its existing Business License Ordinance. The ordinance updates key definitions, revises the categories of businesses required to obtain a business license, and establishes an updated fee schedule for businesses, trades, and professions operating within the City. The ordinance also sets forth regulations for vendors, food trucks, and food trailers participating in City-approved tourism events, and establishes new license fees for billboard structures based on the number of advertising panels.

The ordinance also authorizes the City to impose fines on businesses operating without a valid license and permits the filing of liens for unpaid license fees, along with procedures for enforcement and collection.

All ordinances or parts of ordinances in conflict herewith are repealed to the extent of such conflict. This ordinance shall become effective upon adoption and publication as required by law.

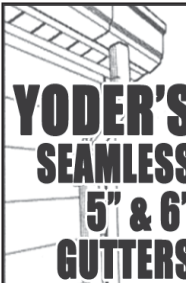

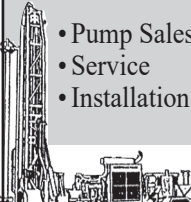
