LSU Shreveport goes 59-0 as first unbeaten college baseball champion

LSU Shreveport became the first college baseball team on record to go unbeaten, finishing 59-0 when it won the NAIA championship in Lewiston, Idaho.

The Pilots' perfect season ended with a 13-7 victory over Southeastern (Florida) on Friday night and gave the 10,000-student school in northwest Louisiana its first national title in any sport.

For 25 years LSU Shreveport has been one of the top programs in the National Association of Intercollegiate Athletics, which governs sports at 241 mostly small colleges across the country.

The Pilots have appeared in the NAIA national tournament every 142-13 in Red River Athletic (45-1 in 2008) in Division III.

Conference play.

LSU Shreveport played only four games decided by one run this season, ranked second in the NAIA with 11.3 runs per game and third with a .361 batting average. The Pilots' 2.38 ERA was more than a run better than the next-closest team, and they led the nation with a .982 fielding percentage.

Josh Gibson, at .436, was one of three players on the team to bat better than .400, and Isaac Rohde struck out an NAIA-leading 146 and had a 2.09 ERA while going 16-0.

The Pilots broke the NAIA-record winning percentage of .935, set when Mount Vernon Nazarene (Ohio) went 43-3 in 1996.

FIFA Club World Cup: start date and teams in soccer's new-look tournament

FIFA's newly expanded Club World Cup kicks off in Miami on June 14, featuring some of soccer's biggest stars like Lionel Messi and greatest teams like Real Madrid. But the launch of the new-look tournament, staged in the United States, also comes with uncertainty over how it will be embraced in an already bloated calendar where soccer is played virtually year-round.

This is world governing body FIFA's big play to get a stronghold in the club game. Until now, club soccer's marquee events have been regional competitions such as the prestigious Champions League, which is organized by European soccer body UEFA.

FIFA hopes the four-yearly event will be to club soccer what the World Cup is to international soccer and establish itself as one of the for another competition.

Some of Europe's biggest teams will take part, including Real Madrid, Manchester City, Bayern Munich, Juventus, this year's Champions League winner Paris Saint-Germain The Club World Cup has and runner-up Inter Milan. titles.

From South America, top Brazilian clubs Fluminense. Flamengo, Palmeiras and Botafogo — all recent winners of Copa Libertadores, South America's top clup competition - will participate, while **River Plate and Boca Juniors** will represent Argentina.

Inter Miami, Seattle Sounders and LAFC lead the U.S. charge. Mexico is represented by Monterrey and Pachuca, while top teams from Asia, Africa and the Oceana are also taking part.

Notable absentees include European giants Barcelona, Liverpool and Manchester United, who failed to meet FIFA's convoluted qualifying criteria based on winning continental titles like the Champions League over the previous four years and ranking points. Countries are also limited to two entrants unless they have more than two winners of continental
