BRECKINRIDGE CIRCUIT COURT - DIVISION 2

Breckinridge Circuit Court. Division 2, met on Wednesday, Dec. 3 with Judge Kenneth H. Goff II presiding.

John T. Hilkey, 35, pleaded not quilty to first degree rape. A pre-trial conference was scheduled for Feb. 4.

Alicia A. Lane, 40, pleaded not quilty to two counts of first degree wanton endangerment and operating a motor vehicle

under the influence of alcohol. A pre-trial conference was scheduled for Jan. 21.

Michael P. Mullins, 46, pleaded not guilty to first degree possession of an unspecified drug, first offense / enhanced; illegal possession of a legend drug; operating a motor vehicle with an expired license; and failure of nonowner to maintain required

insurance, first offense. A pretrial conference was scheduled for Feb. 4.

Alicia N. Rodriguez, 37, pleaded guilty to first degree possession of a controlled substance (meth), first offense, and first degree possession of an unspecified drug, first offense. Sentencing was scheduled for

Thomas A. Dennis, 18, was

sentenced to two years in prison, diverted for five years, for second degree unlawful transaction with a minor.

Joshua G. Kost, 38, pleaded guilty to first degree possession of a controlled substance (meth), second offense / enhanced, and being a convicted felon in possession of a handgun. In another case, he pleaded guilty to trafficking in

fentanyl, first offense. Sentencing was scheduled for Jan. 7.

Nicholas Seth Peek, 35, was sentenced to five years in prison, probated for five years, for first degree wanton endangerment.

Savannah P. Rigsby, 25, was sentenced to three years in prison, probated for five years. for first degree wanton endangerment and driving DUI with a suspended license; 30 days for operating a motor vehicle under the influence of a substance; and 12 months for second degree promoting contraband.

Dalton J. Fulkerson, 26, was sentenced to two years in prison on each of two counts of third degree assault, police / probation officer; and 12 months for third degree assault, EMS / Fire / Rescue Squad.

Breckinridge Circuit Court, Division 1, met on Wednesday, Dec. 3 with Judge Bruce Butler presiding.

Robert G. Geary, 36, pleaded guilty to flagrant non-support. Sentencing was scheduled for Jan. 7.

Christopher H. Wilson, 47, was sentenced to one year in prison for first degree possession of a controlled substance (meth), 2nd offense; 12 months for third degree fleeing / evading police; and 12 months for second degree promoting contraband. The sentences will run consecutively and concurrently

for a total of one year.

Isiah R. Woods, 24, pleaded guilty to first degree possession of a controlled substance (meth), first offense. In another case, he pleaded guilty to first degree possession of a controlled substance (meth), first offense, and possession of marijuana. Sentencing was scheduled for Jan. 7.

Jordan R. Chevalier, 24, pleaded guilty to second degree strangulation / domestic violence and first degree criminal mischief. Sentencing was scheduled for Jan. 21.

sentenced to three years in prison for theft by unlawful taking / disposition of a firearm.

Spence, 36, was sentenced to three years in prison for first degree possession of a controlled substance (meth), first offense, and 120 days for operating a motor vehicle under the influence of alcohol, second offense. In another case, he was sentenced to three years in prison, probated for three years, for tampering with physical evidence.


