## Southern Kentucky Genealogical Society

The Southern Kentucky Genealogical Society invites the public to attend a presentation by Roger Givens on his recent book, "History of Rochester, Butler County, Kentucky," on July 21, 2025, at 6:30 p.m. at the Bowling Green Cumberland Presbyterian Church on Campbell Lane.

Rochester is rooted in an early pioneer settlement known as "The Mouth" for its strategic location at the confluence of the Green and Mud rivers.

In the early 19th century, an early settler named Thomas Riddick platted a town known as "Suffolk" on his father's Revolutionary War land grant at this location. That town was not successful, but the city of Rochester was established in the 1830s and incorporated in 1839.

The book traces the history of Rochester, known as "Queen of the Green," from the Native peoples of the area, through early settlement, the Civil War, and its rise to

prominence through the steamboat era. Businesses, schools, prominent citizens, and events including fires, floods, and accidents are covered along with many photos.

Givens is an amateur historian and former co-publisher of The Butler County Banner newspaper, where he wrote weekly articles about Butler County's historical events,

people, and places. He was co-author with Nancy Richey of "Images of America, Butler County" by Arcadia Publishing. Givens has published two additional books, "African American Life in Butler County, Kentucky – Black Culture, Contributions, and Community" and "A History of Woodbury, Kentucky:

**ORDINANCE NUMBER 2024-25-12**  
**CITY OF EDMONTON, KENTUCKY**  
**AN ORDINANCE OF THE CITY OF EDMONTON RELATING TO STREET-LEGAL SPECIAL PURPOSE VEHICLES**

WHEREAS, 2025 Ky. Acts ch. 89 (hereinafter "the Act") became law on March 26, 2025 and allows for the operation of street-legal special purpose vehicles on certain highways within the Commonwealth of Kentucky if allowed by ordinance of the local government within whose jurisdictional boundaries the highway is located; and

WHEREAS, the Act becomes effective on Friday, June 27, 2025; and

WHEREAS, the City of Edmonton has determined that it is appropriate to allow the operation of street-legal special purpose vehicles on specified highways within the jurisdictional boundaries of the City of Edmonton in accordance with the Act and this ordinance.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the City of Edmonton, Commonwealth of Kentucky:

SECTION 1

Definitions

The definitions set forth in Section 1 (1) of the 2025 Ky. Acts Ch. 89 (hereinafter "the Act"), and as may be amended in the future by the Kentucky General Assembly, are adopted and incorporated by reference as if set forth fully herein.

SECTION 2

Designated Highways

Option 1. Street-legal special purpose vehicles shall be allowed to the extent permitted by the Act on all street and roadways that are located within the jurisdictional limits of the City of Edmonton.

SECTION 3

Exceptions

Street-legal special purpose vehicles shall not be allowed to operate: On any highway, or portion thereof, that is a controlled access system, including but not limited to an interstate or parkway; or

On any highway, or portion thereof, where the United States Department of Agriculture prohibits special purpose vehicles.

SECTION 4

Prohibitions

Street-legal special purpose vehicles are prohibited from traveling a distance greater than twenty (20) miles on a roadway displaying centerline pavement markings.

Minitrucks shall not be operated as street-legal special purpose vehicles on a highway that has been constructed pursuant to a federal highway program.

SECTION 5

Effective Date

This ordinance shall take effect immediately upon its passage and publication.
