IAN Alert

This alert was created by the 2024 General Assembly HB 682. The bill led to the creation of an alert when a child within the autism spectrum disorder is reported missing.

The alert is named for Ian Sousis, a 9-yearold boy with autism spectrum disorder (ASD) who ran away and tragically died of drowning. Statistics from the National Autism Association (NAN) report that 91% of the total U.S. ASD deaths from 2009-2011 were from drowning after wandering away from safe

This system was also

implemented into Kentucky law during the 2024 General Assembly with SB 45.

In 2018, the Ashanti Alert Act was passed nationally in honor of Ashanti Billie, a 19-year-old woman from Virginia who was abducted and found dead in North Carolina 2 weeks later. This system is used for missing persons 18 years or older who may have been abducted, kidnapped, or are in physical danger.

This system provides an alert for people who have aged out of Amber Alerts and do not meet the qualifications for Golden Alerts.

system was created during the 2008 General Assembly. Golden Alerts are used to notify the public of the search and rescue efforts for missing adults with disabilities or impairments.

These may include developmental disabilities, organic brain disorders, as well as physical, mental, or cognitive impairments. These alerts offer something more specific than an Ashanti Alert for adults who may be at a higher risk of danger.

#### **GREEN Alert**

The 2019 General Assembly voted to implement a Green Alert system for Kentucky. This alert system is for missing veterans who are at
