ORDINANCE No. 2025-06-05

ORDINANCE OF THE CITY OF CRAB ORCHARD, KENTUCKY ANNEXING 49.09 ACRES CONTIGUOUS WITH EXISTING BOUNDARY OF THE CITY BY SUMMARY

Comes John Hackley, an attorney licensed to practice in the Commonwealth of Kentucky, and hereby summarizes Ordinance 2025-06-05 for the purposes of both reading and publication of the Ordinance of Annexation, pursuant to KRS 83A.060(4) and (9).

Ordinance 2025-06-05 sets forth the character of the land being annexed, a lot of 49.09 acres with a business located, thereon, currently owned by KLA, Inc. (or KIA, Inc.) and references the relevant statutes allowing an annexation by consent, and also the specific consent of the owners of the land to be annexed, both the private and public.

The full text of the Ordinance sets forth a metes and bounds description, containing 140 calls, or changes of direction, more or less, identifying the lot as being inclusive of and adjacent to Kentucky Highway 39, South of Crab Orchard in Lincoln County, Kentucky.

The Ordinance notes that, as the City of Crab Orchard has zoning, the land being annexed shall be designated as "Commercial."
