Notice is hereby given that on August 1, 2025, Texas Eastern Transmission, LP (Texas Eastern) filed with the Federal Energy Regulatory Commission (FERC) an Abbreviated Application for Certificate of Public Convenience and Necessity and Related Authorizations and Order Approving Abandonment for its proposed Danville Compressor Station Replacement Project (Project) in FERC Docket No. CP25-530 (Application). The purpose of the Project is to ensure the continued safe and reliable operation of the Station by replacing the existing units at the Station, while continuing to meet all currently applicable air emissions requirements. Texas Eastern as a part of the Danville Compressor Station Replacement Project is proposing upgrades to the Danville facility to optimize and strengthen our existing infrastructure network.
