



As required by the Kentucky General Assembly (KRS 132.027), notice is hereby given that the City of Nicholasville will hold a public hearing on Thursday, August 7, 2025 at 5:00 PM at Nicholasville Police Department. 717 N. Main, for the purpose of hearing comments on the proposed real property tax rate for 2025. In 2024, a tax rate of 18.6 cents per \$100 of assessed valuation was set. When applied to total real property assessments, this rate yielded \$5,582,722 in revenue.

It is proposed that this year's real property tax rate be set at 18.6 cents per \$100, which would yield an estimated \$5,830,504 in revenue. The compensating rate of 18.3 cents per \$100 would produce an estimated \$5,736,463 in revenue. The proposed 2025 rate of 18.6 cents per \$100 would yield an estimated \$154,843 of revenue from new property. It is proposed that the 2025 personal property rate be 18.6 cents per \$100, yielding estimated revenue of \$439,565. Additional revenues produced by the proposed rates have been budgeted for general government purposes.
