DUI driver enters guilty plea in LaRue case

Wilson sentenced to 30 years for vehicular homicide, assault

An Elizabethtown man could spend up to 30 years in prison after admitting guilt to driving under the influence of methamphetamine and causing the deaths of two people in LaRue County.

In the late hours of July 17, 2022, Kentucky State Police was dispatched to a head-on, two-vehicle fatal collision in the 2000 block of Bardstown Road in LaRue County. Investigation

revealed that Robert Wilson, 35, was traveling south in a 2009 Chrysler 300 when he crossed the center line and into the path of Tessie McNear, of Hodgenville, who was operating a 2008 Dodge Charger.

A passenger in Wilson's vehicle, Victoria Sharp, 34, of Lebanon, was pronounced deceased at the scene. A passenger in McNear's vehicle, Carla Parker, 41, of Sonora, was transported to Baptist Health Hardin, where she

was later pronounced deceased from her injuries. McNear and her 7-year-old daughter, Kinlea, suffered serious life-threatening physical injuries from the collision.

Wilson was indicted by a LaRue County grand jury in November 2023 and charged with two counts of wanton murder, two counts of first-degree assault and one count of first-degree persistent felony offender.

According to LaRue's Commonwealth Attorney Kyle Williamson, the case was mediated and ultimate-

ly resulted in a negotiated plea agreement. Entered on April 21, Wilson pled guilty and was sentenced to the maximum of 20 years on two counts of vehicular homicide when under the influence and 10 years on two counts of first-degree assault.

The 10-year sentence will run consecutively to the 20-year sentence, for a total of 30 years to serve; Wilson will be required to serve a minimum of 20 years before he is eligible for parole.

Wilson is lodged in the Marion County Jail.
