But Bardstown won the 4x200 relay, Tyler Harmon won the shot put and Tykeem Taul-Williams won the high jump and triple jump as the Tigers scored 83 points — giving them enough room to hold off runner-up Taylor County by 12 points.

“As a first-year head coach, it’s a huge honor and a huge accomplishment to bring my knowledge and their talent together to bring back a regional championship to Bardstown with them,” Reed said. “When I looked at the results before the meet, we were sitting in fourth place. I told the kids that it was up for grabs and we just had to come to compete. They did just that. They dug down deep and pulled it off.”

Harmon won the shot put with a heave of 48 feet, 3 inches, and Kaden Stone was fourth in the event (42-03.50). Stone was also third (127-06) and Harmon sixth (121-09) in the discus.

Taul-Williams won the triple jump (43-03.25) and KJ Stafford was third (42-07.50), and Taul-Williams won the high jump (6-2) while Deandre Sheckles was third (6 feet).

The Tigers also got valuable points in the 4x100 (second) and 4x400 (fourth) relays, while Riley Hatfield was fourth in the 300 hurdles (44.75 seconds) and seventh in the 110s (18.81). Stafford was fourth (20 feet) and Christian Yocum eighth (18-05) in the long jump.

The Tigers overcame a windy day Saturday and having the meet delayed Friday to win the title.

“We had our focus on Friday, but Mother Nature had other plans,” Reed said. “We had to regroup and refocus for Saturday. We had some bumps in the road, but I knew they wanted it just

as bad as the coaches did and they didn't let it get to them.”

Thomas Nelson placed eighth with 38 points with only five athletes competing.

Riku Sugie swept the 1,600- and 3,200-meter runs, winning the 1,600 in 4:28.39 and the 3,200 in 9:49.16. Daniel Filiatreau was second in the 1,600 (4:38.09) and runner-up in the 3,200 (10:36.67), while Adrian Constantino took fifth in the pole vault (8-06).

Nelson County did not score any team points on the day. Owen Kelley placed 10th in the discus (98-06), while Eli Downs was 11th in the shot put (35-03).

On the girls' side, Bardstown placed third with 72 points behind the strength of three wins and a runner-up finish from McKayla Moore and runner-up showings from Ariona Pope and Zarionha Railley.

Moore won the 100 dash (12.90 seconds), the

300 hurdles (48.42) and the 200 dash (26.72) and was second in the 100 hurdles (16.90), while Pope took second in the shot put (33-11.50).

Railley was second (15-05) and Claire Buzick third (15 feet) in the long jump, while Railley was also fourth in the triple jump (30-07) and tied for seventh with Thomas Nelson's Aubrey Hey in the high jump (4-6). Laken Blanford took fourth in the high jump (4-8), and Buzick

was fifth in the 100 dash (13.47). The Tigers were also fifth in the 4x100 (52.53).

Thomas Nelson placed fifth with 51 points.

Baili Hoten won the 1,600 (5:20.74) and 3,200 (11:56.75), while Adalyn Filiatreau was runner-up in the 3,200 (12:41.34). Alex Benningfield took fourth in the 200 dash (27.94) and fifth in the long jump (14-11), and Claire Dewitt was sixth in the 1,600 (6:00.04).

Sarah Monin placed fourth (6-6) and Faith Lanham fifth (6-0) in the pole vault, while the Generals were also third in the 4x400 (4:32.48) and fourth in the 4x800 (10:45.93).

Nelson County placed 13th with three points. Bella Burkhead placed fifth in the 1,600 (5:59.74) and seventh in the 800 (2:53.58).

CLASS 1A REGION 2

It came down to the very last race for the Bethlehem boys, but they eked out a win over Green County in dramatic fashion at McLean County.

The Eagles placed fourth in the 4x400 relay, giving them just enough points to hold off the Dragons in the race for the team title by two points.

“Green County has won the region the last seven or eight years, and they have had a choke hold on our region like we do in cross country,” longtime Bethlehem coach Jimi Burress said. “Knocking them off was a heckuva an accomplishment for us.”

Isaac Riggs won the 800 (2:03.16), 1,600 (4:37.07) and 3,200 (10:02.22), while Grant Greenwell was runner-up in the 1,600 (4:40.33) and 3,200 (10:23.11) and third in the 800 (2:06.13).

Teegan McCauley won the discus, breaking the school record with a heave of 169 feet, 3 inches, while Matthew Stephens was third (46-9) and McCauley fourth (45-3) in the shot put. Dylan Canterna tied for first in the high jump (6 feet), but was edged out on a tiebreaker.

The Eagles were also fourth in the 4x800 (9:02.12) and fourth in the 4x400 (3:45.60), and Zander Smith placed fifth in the 200 dash (23.44).

The Banshees, meanwhile, placed 13th with five points. Bethlehem was fourth in the 4x800 (12:18.15) and sixth in the 4x200 (2:05.41).

Cam Drake drove a single to deep right field, scoring Jake Carroll, to cut the lead to 3-1. Bethlehem opened things up in the fourth, however, as Robinson smacked his homer to left-center field to tie it.

“I just missed one in my first at-bat, but I got a hold of that one,” Robinson said. “I hit it hard and it went out.”

With two outs, Carroll singled to drive in Owen Scholes and then scored when Drake reached on an error, and Blake Spalding's RBI single up the middle made it 6-3.

The Eagles stretched the lead to 8-3 in the fight, when Scholes scored on a dropped third strike and Grand Robinson scored on a sacrifice fly by Abbott Masterson.

Bethlehem's final run came in the sixth on an RBI double from Ethan Gibbs.

“We just had to make adjustments, and that's what we did. We came out on top because of it,” Nolan Robinson said. “We just put the ball in play and stopped having bad at-bats. Gibby was throwing strikes, and he kept us in the game. He was consistent for us.”

Gibbs went the distance for the win, striking out three while allowing

four hits, two earned runs and two walks. Caleb Nalley doubled

for Bardstown's only extra-base hit of the night, while Metcalfe, Cooper Bray and Ethan Gosser each had one single.


Gosser took the loss for the Tigers, working four innings. The left-hander struck out two while allowing six hits, four earned runs and one walk. Preston Ferriell struck out six over two innings of relief.

Bardstown ends the season with a 6-17 record. The Tigers will have to replace four seniors in Nalley, Brazan Harman, Nathan King and Landen Snellen.

Bethlehem moved on to meet top-seeded Nelson County in the tournament semifinals.

The semifinals were originally scheduled for Tuesday, but were moved back to today after storms moved through the area Tuesday. The Eagles and Cardinals are set to meet at 5:30 p.m., followed by Thomas Nelson and Washington County at 8.

Because more heavy rain was expected Tuesday night, Bethlehem Athletic Director Gilly Simpson said the semifinals games have been moved to the Elizabethtown Sports Park. The championship game is scheduled for 6:30 p.m. Thursday at Dean Watts Park.


