

# Kentucky adds 5 non-conference games, including Indiana

LEXINGTON — Kentucky announced five non-conference games for the 2025-26 basketball schedule, including a home date with Indiana on Dec. 13.

All five games added will be in Rupp Arena.

Loyola University Maryland comes to town Nov. 21, Tennessee Tech — coached by former UK great John Pelphrey — visits Nov. 26, North Carolina Central comes to Lexington Dec. 9 and Bellarmine on Dec. 23.

The game with Indiana has been long-awaited. The Cats and Hoosiers have not played since the 2016 NCAA Tournament, but this will be the first in a four-game series.

UK is expected to add additional non-conference foes, along with the Southeastern Conference slate, to complete the 2025-26 schedule.

The Cats also have a home game in the SEC-

ACC Challenge still to be decided.

Television networks and game times will be announced later.

Kentucky, under Coach Mark Pope, is coming off the program's first Sweet 16 appearance since 2019 and had a 24-12 season which featured wins over an NCAA-record-tying eight Associated Press top 15 foes.

Pope has put together a strong transfer portal group along with several freshmen who are expected to contribute. Otega Owhe, last year's leading scorer, is testing the NBA waters but is expected to return for his senior season.

Kentucky will likely be ranked in the preseason top 10 if Owhe decides to return.

# Play ball! Things to know entering the NCAA baseball regionals

OMAHA, Neb. — The NCAA baseball tournament opens Friday with play in 16 double-elimination regionals.

Regional winners advance to best-of-three super regionals next week, and the final eight go to the College World Series in Omaha, Nebraska, beginning June 13.

## WHO'S HOT

Northeastern's 27-game win streak is the longest in Division I since Fairfield rolled off 28 straight in 2021. The Huskies (48-9) are making their fourth NCAA appearance since 2018 under Mike Glavine, younger brother of Baseball Hall of Fame member Tom Glavine. The Huskies are the No. 2 regional seed in Tallahassee, Florida, and open against Mississippi State.

No. 13 national seed Coastal Carolina (48-11) brings an 18-game streak into its home regional. The Chanticleers swept the Sun Belt regular-season and tournament titles under Kevin Schnall, who took over for longtime coach Gary Gilmore this year. They open against Fairfield.

Columbia (29-17) has won nine in a row and 16 of 17. The Ivy League champions are a No. 4 regional seed and meet No. 16 national seed Southern Mississippi.

## WHO'S NOT

Arizona State (35-22) and Kentucky (29-24) each have lost four straight.

The Sun Devils are batting .266 with a total of 12 runs and two homers over their past four and are coming off a 2-0 loss to BYU in the Big 12 Tournament.

The Wildcats lost their final regular-season series against No. 1 national seed Vanderbilt by a total of four runs and then lost 5-1 to Oklahoma in the SEC Tournament.

## STILL WAITING

East Carolina (33-25), which received the American Athletic's automatic bid by winning the conference tournament as a No. 6 seed, has never reached the College World Series in 34 previous NCAA Tournament appearances, the longest streak of its kind. The Pirates are in the field for the ninth time in 10 years.

# UK baseball earns third straight NCAA Tournament bid

## WKU, Murray also among 64 teams

For the first time in program history, Kentucky baseball is NCAA Tournament bound for the third straight season.

Kentucky was selected as the No. 3 seed in the Clemson Regional during Monday's NCAA Tournament selection show and will begin postseason play Friday.

The Clemson Regional will be hosted by the national No. 11 seeded Clemson Tigers, who posted a 44-16 record and are ranked No. 9 in the RPI.

In the opening round, Kentucky will face the No. 2 seeded West Virginia Mountaineers, who went 41-14 during the regular season and rank No. 28 in the RPI.

Kentucky and West Virginia's matchup will be a rematch of the 2023 Lexington Regional semifinals that saw the Cats knock out the Mountaineers with a 10-0 victory.

The No. 4 seed in the regional will be USC Upstate, which will play its first game against Clemson.

The Clemson Regional will be paired with the Baton Rouge Regional hosted by No. 6 overall seed LSU.

LSU will welcome No. 2 seeded Dallas Baptist, No. 3 Rhode Island and No. 4 Little Rock for its regional.

With the bid, ninth-year Kentucky head coach Nick Mingione has led the Cats to four NCAA Tournament appearances (2017, 2023, 2024 and 2025). Overall, it is UK's 10th NCAA Tournament appearance.

This trip will be the first time he will take his team on the road for a regional, as UK served as hosts in each of the first three appearances under Mingione, winning the regional title all three times.

Kentucky lost in the Super Regionals on the road in both 2017 (Louisville) and 2023 (LSU) but last year swept Oregon State at home as the country's No. 2 overall seed to advance to its first-ever College World Series, where it went 1-2.

This spring, the Cats went 29-24 with a 13-17 SEC record.

They sat firmly on the NCAA Tournament bubble after they were swept in their final series of the season by eventual SEC Tournament champion Vanderbilt in a series where the team blew two ninth inning leads.

Kentucky then lost to Oklahoma in its SEC Tournament opener but with an RPI ranking of 38 and series wins over then-No. 4 Tennessee and No. 17 Oklahoma on its resume, the Cats did enough to crack the field.

Kentucky is one of 13 SEC teams to make the field. Eight will serve as hosts, while the Cats join Florida, Mississippi State,

Alabama and Oklahoma as one of the five at-large teams from the country's top baseball conference.

The time of Kentucky's NCAA Tournament opener against West Virginia will be announced later.

Western Kentucky University's baseball team, which won the Conference USA Tournament, will be a No. 3 seed and Murray State University, which won the Missouri Valley Conference Tournament, will be a No. 4 seed.

Both are in the Oxford Regional at Ole Miss.
