and conspiracy to murder, while Brooks Houck, Rogers' ex-boyfriend, is charged with murder and tampering with physical evidence. Houck and Joseph Lawson go on trial June 24 in Warren Circuit Court.

Nelson Circuit Judge Charles Simms III is presiding over both trials; Steven Lawson's trial began Tuesday. Darren Wolff and Zach Buckler are representing Lawson, while Shane Young and his staff at the Hardin County Commonwealth's Attorney's Office are prosecuting the case.

#### **DIGITAL FORENSICS EXPERTS DISCUSSES CELL PHONE TRACKING**

Det. Tim O'Daniel, who heads up the Louisville Metro Police's Digital Forensics Unit, took the stand after lunch Wednesday, and described what he found when he did deep analysis of Steven Lawson's call detail records from the days before and after Rogers' disappearance.

"It's a beefed-up version of your call records," O'Daniel said. "It's sort of like a time machine to take you back and see how the

With it, O'Daniel was able to track what calls Steven Lawson made and received at critical junctures, including during the time Rogers' vehicle was abandoned on the Bluegrass Parkway Mile Marker 14 late July 3, 2015, and stretching into July 4. It has been revealed in testimony that Joseph Lawson drove Rogers' car to the Parkway, and Steven Lawson picked him up. Rogers' body has yet to be found.

O'Daniel described how cell phones communicate with the available towers to "find the clearest and best signal" for the call. He said that while the phone won't always pick the immediately closest tower, they can pinpoint it to a general area. Records from 2015 show Lawson making several calls within minutes of each other on the weekend in question, indicating a path of travel along the Bluegrass Parkway.

Multiple calls were made back and forth July 3-4, 2015, between Steven Lawson, his son, his then-

wife Tammy, and Houck. Under cross-examination, Buckler inquired as to the accuracy of the locations, and O'Daniel replied that while it can't totally pinpoint an exact location, it gets within the "general area," and that he has used that technique to solve

crimes in the past.

Melissa Dover, a crime and intelligence analyst with the Elizabethtown Police Dept. was called next; she also performed cell phone record analysis on Steven Lawson's phone.

She revealed call and text records between Steven, Joseph and Tammy Lawson, and Houck, and showed where kev records had been deleted, possibly in the interest of covering up Rogers' disappearance.

Dover also read several text exchanges between Joseph and Steven, further demonstrating the conspiracy angle the prosecution is trying to prove.

During cross-examination, Buckler asked if it is possible for a phone on its own — and not at the behest of the phone owner — to "batch delete" old calls, and Dover confirmed that can happen, but only if the phone user has activated the "delete old calls" setting for a specific period of time.

Dover confirmed this was true, but she pinpointed that only select calls were deleted from Lawson's phone, while others remained from time in question.

#### **LAWSON GRAND JURY TESTIMONY COMES INTO PLAY**

Shannon Burba is the grand jury coordinator

in Young's office in Hardin County, and she was responsible for gathering the grand jury for a six-month term covering March-November 2023, during which time Steven Lawson was indicted and testified three times.

Burba also handled the recording of the testimony during that time, and audio recordings from May 10, June 14, and Sept. 20 of 2023 were played in court Wednesday.

Part of Lawson's May 10, 2023, grand jury testimony involved Rogers' car being towed to a property on Thompson Hill Road in Northern Nelson County, where his son, Joseph, was staying at the time in 2015. In the recording, Lawson alleged that Houck was angry with him and his son about events on July 4 weekend of that year, including some dirt-moving on Thompson Ridge. Lawson indicated he had to stay late to "do the job."

Referring to a call around midnight from Lawson to Houck, Lawson told the grand jury "I stayed till I got it done, and I told (Houck) I got it done."

The testimony also further revealed what Charlie Girdley had testified in Wednesday morning's court session, that he and Joseph Lawson had been riding around drinking, and also met Steven Lawson at the old 62 South bar on Bloomfield Road in Bardstown.

In the June 14, 2023, recorded testimony to the grand jury, Steven Lawson talked about the phone call he received from Brooks Houck in 2015 while Houck was being interviewed by Det. Jon Snow of the Nelson County Sheriff's Office (Snow is now retired).

The phone call was to tell Brooks the car had been moved," Lawson said in the recording.

In the Sept. 20, 2023, recorded testimony, Lawson further describes a conversation between him, his son, Houck and Gird-

ley. In that conversation, Lawson testified, Houck asked him to move Rogers' car (Girdley was not involved in this).

Lawson noticed that his son "had \$300 to \$400 in his hand," suggesting that Joseph Lawson got paid by Houck to move the vehicle.

Lawson also indicated in the recording that Houck had approached him about perhaps killing Rogers. Lawson said he wasn't the man for that job, and that Houck asked him for suggestions of who might, possibly Girdley, who did not get involved, Lawson said.

Later in that recording, Steven Lawson indicated that it was his son who had towed Rogers' car to Thompson Ridge to potentially leave it there, and that Houck was angry over that. Joseph Lawson later took the vehicle to the Bluegrass Parkway on July 3, 2023, Steven testi-

#### **POTENTIAL WITNESS REFUSES SUBPOENA**

In an affidavit filed with Nelson Circuit Court on Wednesday, Lexington private investigator James 'Chip" Devasher said he attempted to deliver a subpoena to Bardstown resident Thomas Jent's residence on Boston Road, requiring nim to testily in the Steven Lawson trial twice.

The first came on May 15, but Devasher agreed to return to Jent's residence at a time more convenient for Jent.

The second attempt came May 20, but Jent refused to take the subpoena. Eventually, Devasher dropped the subpoena inside the open door at Jent's feet.

"Mr. Jent then picked up the subpoena and followed me to my car," Devasher said in his statement. "I then watched Mr. Jent 'wad up' the subpoena and throw it into his trash can located at the end of his driveway. He then asked me to leave his property and repeatedly and adamantly explained how he would not come to court for any reason. I left his property without any further incident."

#### TRIAL EXPECTED TO **WRAP UP FRIDAY**

The trial for Steven Lawson has been moving faster than expected, and Simms indicated that it should be wrapped up by Friday. Testimony continued Thursday morning and afternoon. Go to kystandard.com for coverage of the trial.
