

Beard's vision drew former UK guard Perry to Ole Miss

LEXINGTON — Travis Perry began the second and what he hopes is the final stop of his collegiate basketball career this week.

The former Lyon County High School standout and Kentucky Mr. Basketball arrived in Oxford this week and practiced with the rest of his future teammates at Ole Miss. Perry transferred following a one-year stint at Kentucky.

He opened up about his decision to leave Lexington earlier this week and said it wasn't easy leaving the commonwealth.

"It's a difficult decision for anybody to get in the portal," Perry said. "(I) just felt like at the end of the day, you've got to make the best decision for yourself and your basketball career. You only get so much time to do it, only so much time to play basketball. So felt like I decided that myself, my family, and felt it was best for my basketball career."

Perry averaged 2.7 points in 31 games for Kentucky last season and scored 12 points and dished out four assists in a loss at Alabama.

Ole Miss coach Chris Beard recruited Perry and opted and remained a fan even after he decided to remain with the Wildcats amid a coaching change that brought in Mark Pope.

"I love Travis — he's one of those guys that's addicted to basketball — loves it (and he's) a basketball guy," Beard said during the NCAA Tournament opening round in Milwaukee in March. "I enjoyed recruiting him, getting a relationship with his family.

"In recruiting, you don't get so many more guys than you do get, but I was really happy for him that he found a great fit and played a great role as a freshman for coach Pope's team. He's a guy I always cheer for, have nothing but respect for. That dude's a baller, man. He loves basketball."

Perry added that Ole Miss is the right fit at this time in his career.

"I felt like Coach Beard's vision was exactly what I was looking for," Perry said. "I felt like we had a lot of guys coming here that wanted to win, wanted to compete at a high level. I feel like I could come in and impact that."

On the flip side, Pope said he was "devastated" when Perry entered the transfer portal at the 11th hour last month.

"It was certainly devastating to me personally because I enjoy coaching him so much," he said. "I feel like he has a brilliant upside. I think he was on his way to becoming a legend here at Kentucky. That made me sad. He's going to find a path that works for him, and it's going to be positive. But that was a tough one for us."

'Greatest place on earth:' Noah looks forward to 2nd season with Wildcats

LEXINGTON — Trent Noah had no intention of entering the transfer portal following his freshman campaign.

"This is the greatest place on earth, and I love Coach (Mark) Pope's vision for me," Noah said last week. "He sees the same kind of path that I see. That's what we're looking to do this year and on the way, win number nine."

Going into his second season with the Wildcats, the former Harlan County High School standout knows what to expect on and off the court.

"Having a year under my belt (makes it easier)," he said. "College basketball is in a whole world of its own. It's nothing like high school basketball. So, coming back to Year 2, knowing what to expect, knowing how the coaching staff does it, is definitely, definitely helps me out."

Looking back, Noah admitted he "had no idea what to expect" when he arrived on campus last summer.

"It (was) completely brand new to me last year, so now I kind of know how practices are structured and how things go, how the season works, and into more detail, like when official practice starts, and stuff like that," he said. "I think little things like that are good to know."

This time around, Noah will be without teammate and classmate Travis Perry, who transferred to Ole Miss during the offseason. Noah was aware Perry was considering his alternatives, but still was surprised when he entered the transfer portal at the 11th hour.

"It stung," Noah said. "I did everything I could to keep him here. He was one of my good friends, and he's an excellent player, but at the end of the day, you've got to do what's best for you, and that's what he thought was best for him. I love and wish him the best, not looking forward to playing him, that's for sure."

Noah likes the makeup of this year's squad and said the Wildcats are bonding both on and off the court.

"I feel like it'll be just like last year," he said. "I think that the BBN will fall in love with the new guys, especially Coach Pope again. They're excellent human beings once again, so that always makes it even better and more enjoyable to play with (guys like that)."

The team had practice last Monday and has been watching the NBA Finals, among other activities, to speed up the chemistry process.

"We've been just kind of kicking in the lodge, playing ping pong, stuff like that," he said. "The camps really cool, because that's kind of your first experience, and you get to play two-on-two with two dads, and you just kind of get to mess around, joke around with the team. That's an important piece for us."

Although he's now considered more of a veteran, Noah still finds it hard to believe he's wearing the blue and white.

"It's kind of still surreal to me that I get to wake up and put on a Kentucky (jersey)," he said. "It's, it's crazy. I mean, growing up watching it, and now I'm here. I've been here over 365 days, and it still feels like the very first time I put it on. It's special. It's like magic."
